Act No. 28, 1971

UNIVERSITY OF FORT HARE AMENDMENT ACT, 1971.

ACT

To amend the provisions of the University of Fort Hare Act, 1969, to provide for the appointment of a vice-rector; to provide for an alteration of the constitution of the said university and of the council and the senate of the said university; to authorize the rector of the said university to delegate his powers to the said vice-rector; and to provide for incidental matters.

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

section 4 of
Act 40 of 1969.

1. Section 4 of the University of Fort Hare Act, 1969 (hereinafter referred to as the principal Act), is hereby amended by the insertion after paragraph (b) of the following paragraph:

“(bA) a vice-rector;”.

Insertion of
section 7A in
Act 40 of 1969.

2. The following section is hereby inserted in the principal Act after section 7:

“Vice-rector
of the
University.

7A. (1) The vice-rector shall be appointed by the council with the approval of the Minister, and his conditions of service, and his powers, privileges, duties and functions shall, subject to the provisions of this Act, be as determined by the council with the approval of the Minister.

(2) The rector may from time to time delegate to the vice-rector such of his powers as he may deem fit, but shall not be divested of any power so delegated, and may amend or rescind any decision of the vice-rector taken in the exercise of such power.

(3) The vice-rector shall by virtue of his office be a member of every committee of the council or the senate and of every joint committee of the council and the senate.”.

3. Section 8 of the principal Act is hereby amended—

(a) by the substitution for paragraph (a) of subsection (1) of the following paragraph:

“(a) the rector and the vice-rector of the University;”;

(b) by the substitution for subsection (3) of the following subsection:

“(3) A member of the council other than the rector and the vice-rector, shall hold office for a period of four years unless he submits his resignation in writing to the council or vacates his office for any other reason before the expiry of such period.”; and

(c) by the substitution in subsection (5) for the words preceding paragraph (a) of the following words:

“(5) A member of the council, other than the rector and the vice-rector, shall vacate office if he—”.

Tot wysiging van die bepalings van die Wet op die Universiteit van Fort Hare, 1969, om voorsiening te maak vir die aanstelling van 'n vise-rector; om voorsiening te maak vir 'n verandering van die samestelling van gemelde universiteit en van die raad en die senaat van gemelde universiteit; om die rektor van gemelde universiteit te magtig om sy bevoegdhede aan gemelde vise-rector oor te dra; en om vir bykomstige aangeleenthede voorsiening te maak.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 4 van die Wet op die Universiteit van Fort Hare, 1969 (hieronder die Hoofwet genoem), word hierby gewysig deur na paragraaf (b) die volgende paragraaf in te voeg: „(bA) 'n vise-rector;”.

2. Die volgende artikel word hierby in die Hoofwet na artikel 7 ingevoeg:
„Vise-rector van die Universiteit. 7A. (1) Die vise-rector word deur die raad met goedkeuring van die Minister aangestel, en sy diensvoorwaardes, bevoegdhede, voorregte, pligte en werksaamhede is, behoudens die bepalings van hierdie Wet, dié wat die raad met die goedkeuring van die Minister bepaal.

(2) Die rektor kan na goeddunke van tyd tot tyd aan die vise-rector van sy bevoegdhede oordra, maar word nie onthef van 'n bevoegdheid aldus oorgedra nie, en kan 'n besluit van die vise-rector geneem in die uitoefening van sodanige bevoegdheid, wysig of intrek.

(3) Die vise-rector is ampshalwe lid van elke komitee van die raad of die senaat en van elke gesamentlike komitee van die raad en die senaat.”.

3. Artikel 8 van die Hoofwet word hierby gewysig—

(a) deur paragraaf (a) van subartikel (1) deur die volgende paragraaf te vervang:

„(a) die rektor en die vise-rector van die Universiteit;”;

(b) deur subartikel (3) deur die volgende subartikel te vervang:

„(3) 'n Lid van die raad, behalwe die rektor en die vise-rector, beklee sy amp vir 'n termyn van vier jaar tensy hy voor verstryking van dié termyn sy bedanking skriftelik by die raad indien of sy amp om 'n ander rede ontruim.”; en

(c) deur in subartikel (5) die woorde wat paragraaf (a) voorafgaan deur die volgende woorde te vervang:

„(5) 'n Lid van die raad, behalwe die rektor en die vise-rector, ontruim sy amp—”.

4. Section 10 (1) of the principal Act is hereby amended by the insertion after paragraph (a) of the following paragraph:
“(aA) the vice-rector of the University, who shall be the vice-chairman.”.

5. This Act shall be called the University of Fort Hare Amendment Act, 1971.
