EXTENSION OF UNIVERSITY EDUCATION
AMENDMENT ACT, 1971.

REPUBLIC OF SOUTH AFRICA GOVERNMENT ACT

To amend the Extension of University Education Act, 1959, in order to make special provision in regard to the admission of certain persons to certain universities; and to provide for incidental matters.

(Afrikaans text signed by the State President.)
(Assented to 30th April, 1971.)

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Substitution of section 31 of Act 45 of 1959.

1. (1) The following section is hereby substituted for section 31 of the Extension of University Education Act, 1959 (hereinafter referred to as the principal Act):

"Limitation of the registration or attendance of non-white persons as students of certain universities.

31. (1) No non-white person who was not registered as a student of a university established by Act of Parliament, other than—
 (a) the University of South Africa; or
 (b) any such university established for—
 (i) any Bantu national unit referred to in section 2 (1) of the Promotion of Bantu Self-government Act, 1959 (Act No. 46 of 1959); or
 (ii) persons who in terms of the provisions of the Population Registration Act, 1950 (Act No. 30 of 1950), are coloured persons, before the commencement of the Extension of University Education Amendment Act, 1971, shall register with or attend any university other than that mentioned in paragraph (a) or (b) as a student without the written consent of the Minister: Provided that this section shall not apply to non-white persons in respect of their registration and attendance as students at the Medical School.

(2) Consent under subsection (1) shall be granted in respect of—
 (a) a specified university; and
 (b) a specified degree, diploma or certificate.

(3) The Minister may withdraw his consent granted under subsection (1) if the student concerned takes a course of study or training other than that for the degree, diploma or certificate in respect of which the consent was granted."

(2) Any consent granted by the Minister under section 31 of the principal Act, as applied by Proclamations Nos. 221 and 223 of 1959, before the commencement of this section, shall be

Tot wysiging van die Wet op Uitbreiding van Universiteitsopleiding, 1959, ten einde besondere voorsiening met betrekking tot die toelating van sekere persone tot sekere universiteite te maak; en om vir bykomstige aangeleenthede voorsiening te maak.

(Goedgekeur op 30 April 1971.)

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. (1) Artikel 31 van die Wet op Uitbreiding van Universiteitsopleiding, 1959 (hieronder die Hoofwet genoem), word hierby deur die volgende artikel vervang:

„Beperking op die inskrywing of bywoning van nie-blankes as studente van sekere universiteite.

31. (1) Geen nie-blanke wat nie voor die inwerkingtreding van die Wysigingswet op Uitbreidingswet van Universiteitsopleiding, 1971, as student van 'n by Parlementswet ingestelde universiteit, behalwe—
(a) die Universiteit van Suid-Afrika; of
(b) so 'n universiteit ingestel vir—
(i) 'n Bantoe-volkseenheid bedoel in artikel 2 (1) van die Wet op die Bevordering van Bantoe-selfbestuur, 1959 (Wet No. 46 van 1959); of
(ii) persone wat ingevolge die bepalings van die Bevolkingsregistrasiewet, 1950 (Wet No. 30 van 1950), gekleurdes is,
ingeskryf was nie, mag hom as student by 'n ander universiteit as dié genoem in paragraaf (a) of (b) inskryf of dit as student bywoon sonder die skrifte-like toestemming van die Minister nie: Met dien verstande dat hierdie artikel nie op nie-blankes ten opsigte van hulle inskrywing en bywoning as studente aan die Mediese Skool van toepassing is nie.

(2) Toestemming word kragtens subartikel (1) verleen ten opsigte van—
(a) 'n bepaalde universiteit; en
(b) 'n bepaalde graad, diploma of sertifikaat.

(3) Die Minister kan sy toestemming wat kragtens subartikel (1) verleen is, intrek indien die betrokke student 'n ander studie- of opleidingskursus volg as dié vir die graad, diploma of sertifikaat ten opsigte waarvan die toestemming verleen is.”.

(2) 'n Toestemming wat deur die Minister kragtens artikel 31 van die Hoofwet, soos by Proklamasies Nos. 221 en 223 van 1959 toegepas, voor die inwerkingtreding van hierdie artikel

deemed to have been granted under that section as substituted by this section, and the said Proclamations Nos. 221 and 223 of 1959 are hereby repealed.

(3) Any non-white person who at any time prior to the commencement of this section registered with, or who during any period prior to such commencement attended as a student, any university established by Act of Parliament with which he would lawfully have been entitled to be registered at that time under section 31 of the principal Act as substituted by this section, or which he would lawfully have been entitled to attend as a student during that period under that section, as so substituted, if that section as so substituted had been in force at that time or during that period, shall be deemed to have lawfully registered with that university at that time, or to have lawfully attended it as a student during that period, under that section as so substituted.

2. (1) The following section is hereby substituted for section 32 of the principal Act:

"Prohibition of registration or attendance of non-white persons as students of certain universities.

32. (1) As from a date to be fixed by the State President by proclamation in the *Gazette* for the purposes of this subsection, no non-white person shall register with or attend any university established by Act of Parliament, other than—

- (a) the University of South Africa; or
- (b) any such university established for—

- (i) any Bantu national unit referred to in section 2 (1) of the Promotion of Bantu Self-government Act, 1959 (Act No. 46 of 1959); or

- (ii) persons who in terms of the Population Registration Act, 1950 (Act No. 30 of 1950), are coloured persons,

as a student: Provided that the provisions of this subsection shall not be construed as preventing any non-white person who is registered as a student at a university other than that mentioned in paragraph (a) or (b) on the said date, or who was so registered prior to the said date, from completing at that university the course of study or training for the degree, diploma or certificate for which he is or was so registered: Provided further that this subsection shall not apply to non-white persons in respect of their registration and attendance as students at the Medical School.

(2) Different dates may be fixed under subsection

(1) in respect of—

- (a) different universities;
- (b) separate degrees, diplomas or certificates of a university;
- (c) Bantu persons;
- (d) non-white persons other than Bantu persons; and

- (e) different ethnic or other groups of non-white persons."

(2) Proclamation No. R.434 of 1960 is hereby repealed.
