OPMERKINGS:

1. Seep en organiese oppervlakspanning-aktiewe middels, preparate en waspreparate, word van verkoopreg vrygestel.
2. Die verkoopreg op breimasjiene van 'n soort gebruik vir huishoudelike doeleindes en op huishoudelike tipe naaimasjiene met inbegrip van meubels wat daarvoor ontwerp is, word van 15% na 10% verlaag.
3. Die verkoopreg op omnibusse met 'n sitruimte van minstens 10 sitplekke en hoogstens 20 sitplekke, motorkarre, stasiewaens en dergelike dubbeldoelmotorvoertuie, met 'n waarde vir doeleindes van verkoopreg van meer as R2 050 maar hoogstens R2 150 word van 15% na 10% verlaag.
4. Die verkoopreg op horlosies en uurwerke word van 30% na 25% verlaag.

NOTES:

1. Soap and organic surface-active agents, preparations and washing preparations are exempted from sales duty.
2. The sales duty on knitting machines of a kind used for domestic purposes and on domestic type sewing machines including furniture designed therefor, is decreased from 15% to 10%.
3. The sales duty on omnibuses with a seating capacity of not less than 10 seats and not exceeding 20 seats, motor cars, station wagons and similar dual purpose motor vehicles, with a value for sales duty purposes exceeding R2 050 but not exceeding R2 150 is decreased from 15% to 10%.
4. The sales duty on watches and clocks is reduced from 30% to 25%.
