WET OP PROVINSIALE LISENSIEGELDE, 1972.

# WET

**Om voorsiening te maak vir die storting in die provinsiale inkomstefondse van 'n bedrag van hoogstens viermiljoen rand ten opsigte van invorderings van sekere lisensiegelde en boetes; en om vir bykomstige aangeleenthede voorsiening te maak.**

*(Afrikaanse teks deur die Staatspresident geteken.)  
(Goedgekeur op 29 Maart 1972.)*

**DAAR WORD BEPAAL** deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Storting van sekere lisensiegelde en boetes in provinsiale inkomstefondse.

1. (1) Ondanks die bepalings van artikel 12 van die Wet op Lisensies, 1962 (Wet No. 44 van 1962), val 'n bedrag (wat viermiljoen rand nie oorskry nie) wat gedurende die tydperk van twaalf maande eindigende op 31 Maart 1972 ingevorder word ten opsigte van lisensiegelde wat ingevolge genoemde Wet en boetes wat ingevolge artikel 10 van daardie Wet betaalbaar is, aan die provinsiale inkomstefondse toe.

(2) Die gedeelte van die in subartikel (1) bedoelde bedrag wat in die inkomstefonds van 'n besondere provinsie gestort word, word ooreenkomstig die formule—

$$Y = \frac{A}{B} \times C$$

vasgestel, in welke formule—

- (a) „Y” die gedeelte van die bedrag voorstel wat vasgestel moet word;
- (b) „A” die bedrag voorstel wat, volgens 'n beraming van die Sekretaris van Binnelandse Inkomste, in bedoelde provinsie gedurende die tydperk en ten opsigte van die lisensiegelde en boetes soos bedoel in subartikel (1) ingevorder sal word;
- (c) „B” die bedrag voorstel wat, volgens 'n beraming van die Sekretaris van Binnelandse Inkomste, in al die provinsies van die Republiek gedurende bedoelde tydperk ten opsigte van bedoelde lisensiegelde en boetes ingevorder sal word;
- (d) „C” die in subartikel (1) bedoelde bedrag voorstel.

Kort titel en inwerkingtreding.

2. Hierdie Wet heet die Wet op Provinsiale Lisensiegelde, 1972, en word geag op 1 April 1971 in werking te getree het.

## PROVINCIAL LICENCE DUTIES ACT, 1972.

Act No. 25, 1972

**ACT**

**To provide for the payment into the provincial revenue funds of an amount not exceeding four million rand in respect of collections of certain licence duties and penalties; and to provide for incidental matters.**

*(Afrikaans text signed by the State President.)  
(Assented to 29th March, 1972.)*

**BE IT ENACTED** by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. (1) Notwithstanding the provisions of section 12 of the Licences Act, 1962 (Act No. 44 of 1962), an amount (not exceeding four million rand) collected during the period of twelve months ending on 31st March, 1972, in respect of licence duties payable under the said Act and penalties payable under section 10 of that Act, shall accrue to the provincial revenue funds. Payment of certain licence duties and penalties into provincial revenue funds.

(2) The portion of the amount referred to in subsection (1) which shall be paid into the revenue fund of a particular province shall be determined in accordance with the formula—

$$Y = \frac{A}{B} \times C$$

in which formula—

- (a) "Y" represents the portion of the amount to be determined;
- (b) "A" represents the amount which, according to an estimate by the Secretary for Inland Revenue, will be collected in the said province during the period and in respect of the licence duties and penalties referred to in subsection (1);
- (c) "B" represents the amount which, according to an estimate by the Secretary for Inland Revenue, will be collected in all the provinces of the Republic during the said period in respect of the said licence duties and penalties;
- (d) "C" represents the amount referred to in subsection (1).

2. This Act shall be called the Provincial Licence Duties Act, 1972, and shall be deemed to have come into operation on 1st April, 1971. Short title and commencement.
