middels en Veemiddels, 1947, ten einde daardie Wet op die
gebied Suidwes-Afrika van toepassing te maak; en om vir
bykomstige aangeleenthede voorsiening te maak.**

Wysiging van

Wet 60 van 1970.

1. Artikel 1 van die Wet op Misstowwe, Veevoedsel, Landbou-
middels en Veemiddels, 1947 (hieronder die Hoofwet genoem),
word hierby gewysig deur voor die omskrywing van „verkoop”
die volgende omskrywing in te voeg:

„„Republiek’ ook die gebied Suidwes-Afrika;”.

Wysiging van
artikel 16 van
Wet 36 van 1947
soos gewysig deur
artikel 37 van
Wet 28 van 1961.

2. Artikel 16 van die Hoofwet word hierby gewysig deur
subartikel (1) deur die volgende subartikel te vervang:

„(1) ’n Beampte van die Departement van Docane en
Aksyns wat deur die Sekretaris van Docane en Aksyns
daartoe gemagtig is, kan enige hoeveelheid boerderybe-
nodighede wat by ’n hawe of plek in die Republiek geland
word of deur so ’n hawe of plek ingevoer word, aanhou en
monsters daarvan neem.”.

FERTILIZERS, FARM FEEDS, AGRICULTURAL REMEDIES AND STOCK REMEDIES AMENDMENT ACT, 1972. Act No. 17, 1972

ACT

To amend the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act, 1947, so as to apply that Act to the territory of South-West Africa; and to provide for incidental matters.

(English text signed by the Acting State President.)
(Assented to 23rd March, 1972.)

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 1 of the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act, 1947 (hereinafter referred to as the principal Act), is hereby amended by the insertion after the definition of "prescribed" of the following definition:
 "‘Republic’ includes the territory of South-West Africa;”.
Amendment of section 1 of Act 36 of 1947, as amended by section 32 of Act 28 of 1961 and section 1 of Act 60 of 1970.
2. Section 16 of the principal Act is hereby amended by the substitution for subsection (1) of the following subsection:
 “(1) Any officer of the Department of Customs and Excise authorized thereto by the Secretary for Customs and Excise may detain any quantity of farming requisites landed at or imported through any port or place in the Republic, and may take samples thereof.”.
Amendment of section 16 of Act 36 of 1947 as amended by section 37 of Act 28 of 1961.
3. The following section is hereby inserted in the principal Act after section 23:
 “Application of Act to South-West Africa.
 24. This Act and any amendment thereof shall apply also to the territory of South-West Africa, including the Eastern Caprivi Zipfel.”.
Insertion of section 24 in Act 36 of 1947.
4. The Fertilisers, Farm Foods, Seeds and Pest Remedies Ordinance, 1930 (Ordinance No. 15 of 1930), of the territory of South-West Africa is hereby repealed.
Repeal of Ordinance 15 of 1930 of South-West Africa.
5. This Act shall be called the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Amendment Act, 1972, and shall come into operation on a date to be fixed by the State President by proclamation in the *Gazette*.
Short title and commencement.
