Tot wysiging van die bepalings van die Wet op Higiëne by Diereslag, Vleis en Dierlike Produkte, 1967, ten einde bedoelde Wet in die gebied Suidwes-Afrika van toepassing te maak; en om vir bykomstige aangeleenthede voorsiening te maak.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 1 van Wet 87 van 1967.

Invoeging van artikel 42A in Wet 87 van 1967.

Kort titel en inwerkingtreding.

1. Artikel 1 van die Wet op Higiëne by Diereslag, Vleis en Dierlike Produkte, 1967 (hieronder die Hoofwet genoem), word hierby gewysig deur na die omskrywing van „regulasie” die volgende omskrywing in te voeg:
„Republiek” ook die gebied Suidwes-Afrika;”.

2. Die volgende artikel word hierby in die Hoofwet na artikel 42 ingevoeg:

„Toepassing **42A.** Hierdie Wet en enige wysiging daarvan is van Wet in ook in die gebied Suidwes-Afrika, met inbegrip van Suidwes-Afrika. die Oostelike Caprivi Zipfel, van toepassing.”.

3. Hierdie Wet heet die Wysigingswet op Higiëne by Diereslag, Vleis en Dierlike Produkte, 1972, en tree in werking op ’n datum wat die Staatspresident by proklamasie in die Staatskoerant bepaal.

ANIMAL SLAUGHTER, MEAT AND ANIMAL PRODUCTS
HYGIENE AMENDMENT ACT, 1972.

Act No. 36, 1972

ACT

To amend the provisions of the Animal Slaughter, Meat and Animal Products Hygiene Act, 1967, so as to apply the said Act in the territory of South-West Africa; and to provide for incidental matters.

(English text signed by the State President.)
(Assented to 8th May, 1972.)

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 1 of the Animal Slaughter, Meat and Animal Products Hygiene Act, 1967 (hereinafter referred to as the principal Act), is hereby amended by the insertion after the definition of "regulation" of the following definition:

"Republic" includes the territory of South-West Africa;".

2. The following section is hereby inserted in the principal Act after section 42: Insertion of section 42A in Act 87 of 1967.

“Applica- 42A. This Act and any amendment thereof shall

3. This Act shall be called the Animal Slaughter, Meat and Animal Products Hygiene Amendment Act, 1972, and shall come into operation on a date to be fixed by the State President by proclamation in the *Gazette*. Short title and commencement.
