en die Volksraad van die Republiek van Suid-Afrika,
soos volg:—

Wysiging van
artikel 1 van
Wet 37 van 1964.

1. Artikel 1 van die Wet op die Landbounavorsingsrekening,
1964 (hieronder die Hoofwet genoem), word hierby gewysig
deur die omskrywing van „Minister” deur die volgende om-
skrywing te vervang:

„Minister” die Minister van Landbou.”.

artikel 3 van
Wet 37 van 1964.

2. Artikel 3 van die Hoofwet word hierby gewysig deur die
volgende subartikel by te voeg:

„(3) 'n Voorwaarde van 'n skenking in subartikel (2)
bedoel, kan by wyse van ooreenkoms tussen die skenker
en die Minister, handelende in oorleg met die Minister van
Finansies, gewysig word.”.

AGRICULTURAL RESEARCH ACCOUNT AMENDMENT
ACT, 1972.

Act No. 37, 1972

ACT

To amend the provisions of the Agricultural Research Account Act, 1964, relating to the definitions and donations.

*(Afrikaans text signed by the State President.)
(Assented to 8th May, 1972.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 1 of the Agricultural Research Account Act, 1964 (hereinafter referred to as the principal Act), is hereby amended by the substitution for the definition of "Minister" of the following definition:

"'Minister' means the Minister of Agriculture."

2. Section 3 of the principal Act is hereby amended by the addition of the following subsection:

Act 37 of 1964.

"(3) Any condition of a donation referred to in subsection (2), may be altered by agreement between the donor and the Minister, acting in consultation with the Minister of Finance."

3. This Act shall be called the Agricultural Research Account Amendment Act, 1972.
