DEPARTMENT OF JUSTICE

The following Government Notice is published for general information.

PROHIBITION ON GATHERINGS:

SECTION 2 (3)ter OF ACT NO. 17 OF 1956.

1. Whereas I, PETRUS CORNELIUS PELSER, Minister of Justice, deem it necessary for the maintenance of the public peace, I hereby prohibit, in terms of section 2 (3)ter of the Riotous Assemblies Act, 1956 (Act No. 17 of 1956) the assembly in any public place of any public gathering of a political nature, that is to say, a public gathering at which any form of state or any principle or policy of the government of a state is propagated, defended, attacked, criticized or discussed, or which is held in protest against anything; with the exception of such a public gathering which, for as long as it lasts, takes place within the walls of a building.

2. This prohibition applies in the following magisterial districts:

3. This prohibition is of force up to and including 8 July, 1972.

4. Government Notices Nos. 999 and 1017 of 7 June, 1972 are hereby withdrawn.

5. I have issued instructions to the magistrate of each of the districts mentioned in paragraph 2 according to which they may authorize the assembly of such public gatherings.

VERBOD OP BYEENKOMSTE:

ARTIKEL 2 (3)ter VAN WET NO. 17 VAN 1956.

1. Aangesien ek, PETRUS CORNELIUS PELSER, Minister van Justisie, dit nodig ag tot handhawing van die openbare rus, verbied ek hiermee ingevolge artikel 2 (3)ter van die Wet op Oproerige Byeenkomste, 1956 (Wet No. 17 van 1956) die byeenkoms in enige openbare plek van enige openbare samekoms van 'n politieke aard, dit wil sê 'n openbare samekoms waarby enige staatsvorm of enige beginsel of beleid van die regering van 'n staat aangeprys, verdedig, aangeval, veroordeel of bespreek word, of wat in protes teen enigiets gehou word; met uitsondering van so 'n openbare samekoms wat, vir so lank as wat dit duur, binne die mure van 'n gebou plaasvind.
