APPROPRIATION ACT, 1972.

Act No. 87, 1972

ACT

To apply a sum of money towards the service of the Republic for the financial year ending on the thirty-first day of March, 1973.

*(English text signed by the State President.)
(Assented to 16th June, 1972.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. The Consolidated Revenue Fund of the Republic is hereby charged, on the Revenue Account, with such sums of money as may be required for the service of the Republic for the financial year ending on the thirty-first day of March, 1973, as shown in column 1 of Schedule 1. Consolidated Revenue Fund charged with sums of money as shown in column 1 of Schedule 1, on Revenue Account.
2. The Consolidated Revenue Fund of the Republic is further charged, on the Loan Account, with such sums of money as may be required for the service of the Republic for the financial year ending on the thirty-first day of March, 1973, as shown in column 1 of Schedule 2. Consolidated Revenue Fund charged with sums of money as shown in column 1 of Schedule 2, on Loan Account.
3. The Consolidated Revenue Fund of the Republic is further charged, on the South-West Africa Account, with such sums of money as may be required for the service of the Republic for the financial year ending on the thirty-first day of March, 1973, as shown in column 1 of Schedule 3. Consolidated Revenue Fund charged with sums of money as shown in column 1 of Schedule 3, on South-West Africa Account.
4. The money appropriated by this Act shall be applied to the services detailed in the Schedules, and more particularly specified in the Estimates of Expenditure from the Revenue Account, the Loan Account and the South-West Africa Account, as submitted to and approved by Parliament, and to no other purpose. How money to be applied.
5. With the approval of the Minister of Finance, a saving on any sub-head of a vote may be made available to meet excess expenditure on any other sub-head, or expenditure on a new sub-head, of the same vote: Provided that the sums appearing in column 2 of the Schedules shall not be exceeded, nor shall savings thereon be available for any purpose other than that for which the money is hereby granted as indicated in the said Schedules. Minister may approve variation.
6. This Act shall be called the Appropriation Act, 1972. Short title.
