Wet No. 96, 1972

WYSIGINGSWET OP CHIROPRAKTISSYNS, 1972.

WET

Tot wysiging van die Wet op Chiropraktisys, 1971, ten einde verdere vereistes vir die beoefening van chiropraktyk voor te skryf; en sekere persone te magtig om as chiropraktisys te praktiseer.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 1 van Wet 76 van 1971.

1. Artikel 1 van die Wet op Chiropraktisys, 1971, word hierby gewysig deur subartikel (1) deur die volgende subartikel te vervang:

„(1) Niemand mag vir wins as chiropraktisyne praktiseer nie tensy sy naam op die in artikel 2 bedoelde lys verskyn en hy deur die beamppte bedoel in dié artikel, skriftelik in kennis gestel is dat sy naam in daardie lys ingeskryf is.”.

Wysiging van artikel 2 van Wet 76 van 1971.

2. Artikel 2 van die Wet op Chiropraktisys, 1971, word hierby gewysig deur subartikel (1) deur die volgende subartikel te vervang:

„(1) 'n Beamppte in die Departement van Gesondheid, wat deur die Minister van Gesondheid aangewys word, moet 'n lys hou waarin die naam van elke persoon ingeskryf word wat—

(a) binne ses maande na die inwerkingtreding van hierdie Wet ten genoeë van sodanige beamppte bewys voorgelê het—

(i) dat sodanige persoon by gemelde inwerkingtreding—

(aa) vir wins as 'n chiropraktisyne in die Republiek gepraktiseer het; of

(bb) 'n Suid-Afrikaanse burger was en besig was om in die Republiek of elders te studeer ten einde hom as chiropraktisyne te bekwaam; en

(ii) dat die 'Chiropractic Association of South Africa' (hieronder die 'Vereniging' genoem) 'n aanbeveling gedoen het dat sodanige persoon se naam in sodanige lys ingeskryf word; of

(b) binne een maand na die datum bedoel in subparagraph (ii), ten genoeë van daardie beamppte bewys voorlê dat—

(i) sodanige persoon by gemelde inwerkingtreding—

(aa) 'n Suid-Afrikaanse burger was; en

(bb) vir wins as 'n chiropraktisyne elders as in die Republiek gepraktiseer het;

CHIROPRACTORS AMENDMENT ACT, 1972.

Act No. 96, 1972

ACT

To amend the Chiropractors Act, 1971, so as to prescribe further requirements for the practice of chiropractic; and to authorize certain persons to practise as chiropractors.

*(Afrikaans text signed by the State President.)
(Assented to 16th June, 1972.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 1 of the Chiropractors Act, 1971, is hereby ^{Amendment of section 1 of Act 76 of 1971.} amended by the substitution for subsection (1) of the following subsection:

“(1) No person shall practise for gain as a chiropractor unless his name appears on the list referred to in section 2 and he has been informed in writing by the officer referred to in that section that his name has been entered on that list.”.

2. Section 2 of the Chiropractors Act, 1971, is hereby ^{Amendment of section 2 of Act 76 of 1971.} amended by the substitution for subsection (1) of the following subsection:

“(1) An officer in the Department of Health designated by the Minister of Health shall keep a list on which shall be entered the name of every person who—

(a) within six months after the commencement of this Act submitted proof to the satisfaction of such officer—

(i) that at the said commencement such person—
(aa) was practising for gain as a chiropractor in the Republic; or

(bb) was a South African citizen and was studying, in the Republic or elsewhere, in order to qualify as a chiropractor; and

(ii) that the Chiropractic Association of South Africa (hereinafter referred to as the ‘Association’) has made a recommendation that such person’s name be entered on such list; or

(b) within one month after the date referred to in subparagraph (ii), submits proof to the satisfaction of such officer that—

(i) such person was at the said commencement—
(aa) a South African citizen; and

(bb) practising for gain as a chiropractor elsewhere than in the Republic;

- (ii) sodanige persoon vanaf 'n datum na gemelde inwerkingtreding blywend woonagtig in die Republiek geword het; en
- (iii) die Vereniging ten opsigte van sodanige persoon so 'n aanbeveling gedoen het as wat in paragraaf (a) (ii) bedoel word; of
- (c) ten genoeë van daardie beamppte bewys voorlê dat—
- (i) by genoemde inwerkingtreding sodanige persoon—
- (aa) wat verblyf betref, in staat was om Suid-Afrikaanse burgerskap te verkry; en
- (bb) besig was om in die Republiek of elders te studeer ten einde hom as chiropraktisyn te bekwaam;
- (ii) sodanige burgerskap binne twee jaar na genoemde inwerkingtreding aan sodanige persoon verleen is; en
- (iii) die Vereniging ten opsigte van sodanige persoon so 'n aanbeveling gedoen het as wat in paragraaf (a) (ii) bedoel word.”.

Kort titel.**3. Hierdie Wet heet die Wysigingswet op Chiropraktisyns, 1972.**

- (ii) such person became permanently resident in the Republic from a date after the said commencement; and
 - (iii) the Association has in respect of such person made such a recommendation as is referred to in paragraph (a) (ii); or
- (c) submits proof to the satisfaction of such officer that—
- (i) at the said commencement such person was—
 - (aa) as far as residence is concerned, capable of acquiring South African citizenship; and
 - (bb) studying, in the Republic or elsewhere, in order to qualify as a chiropractor;
 - (ii) such citizenship was granted to such person within two years after such commencement; and
 - (iii) the Association has in respect of such person made such a recommendation as is referred to in paragraph (a) (ii).".

3. This Act shall be called the Chiropractors Amendment Short title. Act, 1972.
