#### WETGEWENDE RAAD VAN KAVANGO.— INSTELLING VAN DEPARTEMENTE

Nademaal die Wetgewende Raad van Kavango ingestel is by Proklamasie R. 196 van 1970 met ingang van 14 Oktober 1970;

En nademaal die Staatspresident gemagtig is om by artikel 13 (1) (a) gelees met artikel 6 (2) van die Wet op die Ontwikkeling van Selfbestuur vir Naturellevolke in Suidwes-Afrika, 1968 (Wet 54 van 1968), by proklamasie in die *Staatskoerant* voorsiening te maak ten opsigte van 'n wetgewende raad vir aangeleenthede gemeld in artikel 6 (2) van genoemde Wet op die Ontwikkeling van Selfbestuur vir Naturellevolke in Suidwes-Afrika, 1968, nadat 'n wetgewende raad ingestel is maar voor die eerste sessie van sodanige wetgewende raad;

En nademaal voorsiening gemaak is in Bylae A van Proklamasie R. 238 van 1970 uitgevaardig op 16 Oktober 1970, vir die instelling van sekere departemente ten opsigte van die Wetgewende Raad van Kavango en vir die beheer oor en administrasie van sodanige departemente;

En nademaal genoemde Proklamasie in die *Staatskoerant* uitgevaardig is na die aanvang van die eerste sitting van die Wetgewende Raad van Kavango, naamlik 14 Oktober 1970;

So is dit dat ek kragtens die bevoegdheid my verleen by artikel 14 (1) van die Wet op die Ontwikkeling van Selfbestuur vir Naturellevolke in Suidwes-Afrika, 1968 (Wet 54 van 1968), hierby—

(a) die Uitvoerende Raad van die Wetgewende Raad van Kavango magtig om kragtens artikel 6 (2) van genoemde Wet op die Ontwikkeling van Selfbestuur vir Naturellevolke in Suidwes-Afrika, 1968, die departemente genoem in die Bylae van hierdie Proklamasie in te stel met ingang van 14 Oktober 1970 ten opsigte van aangeleenthede genoem in die Bylae van voornoemde Wet; en

(b) bepaal dat totdat sodanige departemente deur die Uitvoerende Raad van die Wetgewende Raad van Kavango ingestel is, enige bevoegdhede uitgeoefen en pligte en werksaamhede verrig in verband met die

### PROCLAMATION

#### KAVANGO LEGISLATIVE COUNCIL.— ESTABLISHMENT OF DEPARTMENTS

Whereas the Kavango Legislative Council was established by Proclamation R. 196 of 1970 with effect from 14 October 1970;

And whereas the State President is empowered by section 13 (1) (a) read with section 6 (2) of the Development of Self-government for Native Nations in South-West Africa Act, 1968 (Act 54 of 1968), to provide in respect of a legislative council, by proclamation in the *Gazette*, for matters referred to in section 6 (2) of the said Development of Self-government for Native Nations in South-West Africa Act, 1968, after a legislative council has been established but before the first session of such legislative council;

And whereas provision was made in Schedule A to Proclamation R. 238 of 1970, promulgated on 16 October 1970, for the establishment of certain departments in respect of the Kavango Legislative Council and for the control and administration of such departments;

And whereas the said Proclamation was promulgated in the *Gazette* after the commencement of the first session of the Kavango Legislative Council, namely 14 October 1970;

Now, therefore, under and by virtue of the powers vested in me by section 14 (1) of the Development of Self-government for Native Nations in South-West Africa Act, 1968 (Act 54 of 1968), I hereby—

(a) authorise the Executive Council of the Kavango Legislative Council, to establish in terms of section 6 (2) of the said Development of Self-government for Native Nations in South-West Africa Act, 1968, with effect from 14 October 1970, in regard to matters mentioned in the Schedule to the afore-mentioned Act, the departments mentioned in the Schedule to this Proclamation; and

(b) determine that, until such time as such departments have been established by the Executive Council of the Kavango Legislative Council, any powers exercised, and duties and functions performed in
