UNIVERSITY OF SOUTH AFRICA (PRIVATE)
AMENDMENT ACT, 1973.

PRIVATE ACT

To amend the University of South Africa Act, 1959.

(English text signed by the State President.)
(Assented to 30th March, 1973.)

Preamble.

WHEREAS for the better administration and conduct of the University it is expedient to amend the University of South Africa Act, 1959 (hereinafter referred to as the principal Act), so as to change the composition of the Council:

BE IT THEREFORE ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Amendment of section 8 of Act 19 of 1959, as amended by section 2 of Act 13 of 1964 and section 3 of Act 53 of 1967.

1. Section 8 of the principal Act is hereby amended by the deletion of subsection (1) (c).

Short title.

2. This Act shall be called the University of South Africa (Private) Amendment Act, 1973.
