Wet 2 van 1975.

**1.** Artikel 11 van die Wet op Vrugafdrywing en Sterilisasie,  
1975, word hierby deur die volgende artikel vervang:

„Toepassing van Wet in (1) Behoudens die bepalings van subartikel  
Suidwes- (2) is hierdie Wet en 'n wysiging daarvan ook van  
Afrika. toepassing in die gebied Suidwes-Afrika, met inbe-  
grip van die Oostelike Caprivi Zipfel.

(2) By die toepassing van subartikel (1) word 'n  
verwysing in hierdie Wet na artikel 15 van die  
Ontugwet, 1957 (Wet No. 23 van 1957), uitgelê as 'n  
verwysing ook na artikel 2 van die „Meisjes en  
Geestelik Gekrenkte Vrouwen Bescherulings Pro-  
klamatie, 1921“ (Proklamasie No. 28 van 1921), van  
die Administrateur van die gebied Suidwes-Afrika.“.

## ABORTION AND STERILIZATION AMENDMENT ACT, 1976 Act No. 18, 1976

# ACT

To amend the Abortion and Sterilization Act, 1975, so as to further regulate the application of that Act in the territory of South West Africa.

*(Afrikaans text signed by the State President.)  
(Assented to 15 March 1976.)*

**BE IT ENACTED** by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

**1.** The following section is hereby substituted for section 11 Substitution of section 11 of Act 2 of 1975.

“Application 11. (1) Subject to the provisions of subsection (2), of Act in this Act and any amendment thereof shall also apply South West Africa in the territory of South West Africa, including the Eastern Caprivi Zipfel.

(2) For the purposes of subsection (1), any reference in this Act to section 15 of the Immorality Act, 1957 (Act No. 23 of 1957), shall be construed as including a reference to section 2 of the Girls’ and Mentally Defective Women’s Protection Proclamation, 1921 (Proclamation No. 28 of 1921), of the Administrator of the territory of South West Africa.”.

**2.** This Act shall be called the Abortion and Sterilization Short title. Amendment Act, 1976.
