Wet No. 52, 1976

WET OP FINANSIES EN REKENINGS VAN
DIE SPOORWEË EN HAWENS, 1976.

WET

Om voorsiening te maak vir die reëeling van die invordering, ontvangs, beheer, bewaring en uitbetalung van die geld, en die ontvangs, bewaring en beheer van die eiendom, van die Suid-Afrikaanse Spoorweë en Hawens; die reëeling van die Spoorweg- en Hawefonds en -rekening; die ouditering van die rekenings daarvan; en aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Toepaslike wet.

1. Ondanks andersluidende bepalings van die Skatkis- en Ouditwet, 1975 (Wet No. 66 van 1975), word genoemde Wet, met uitsondering van artikels 42 en 47 daarvan, nie op die Spoorweg- en Hawe-administrasie toegepas nie en bly die bepalings van die Skatkis- en Ouditwet, 1956 (Wet No. 23 van 1956), met uitsondering van artikels 11, 12 en 13 daarvan, vir sover hulle op daardie Administrasie van toepassing is, van krag.

2. Hierdie Wet en 'n wysiging daarvan is ook in die gebied Suidwes-Afrika, met inbegrip van die Oostelike Caprivi Zipfel, van toepassing.

3. Hierdie Wet heet die Wet op Finansies en Rekenings van die Spoorweë en Hawens, 1976, en tree op 1 April 1976 in werking.

RAILWAYS AND HARBOURS FINANCES AND ACCOUNTS ACT, 1976.**Act No. 52, 1976****ACT**

To provide for the regulation of the collection, receipt, control, custody and issue of the money, and the receipt, custody and control of the property, of the South African Railways and Harbours; the regulation of the Railway and Harbour Fund and Account; the auditing of the accounts thereof; and matters incidental thereto.

(Afrikaans text signed by the State President.)
(Assented to 23 March 1976.)

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. Notwithstanding any provisions to the contrary contained Applicable law. in the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), such Act, except sections 42 and 47 thereof, shall not be applied to the Railways and Harbours Administration, and the provisions of the Exchequer and Audit Act, 1956 (Act No. 23 of 1956), except sections 11, 12 and 13 thereof, shall, in so far as they apply to that Administration, remain in force.
2. This Act and an amendment thereto is also applicable in Application of Act to South West Africa. the territory of South West Africa, including the Eastern Caprivi Zipfel.
3. This Act shall be called the Railways and Harbours Short title and date of Finances and Accounts Act, 1976, and shall come into operation commencement. on 1 April 1976.
