## WET

Om voorsiening te maak vir die vervanging van petisieverrigtings in geregshoue.

**DAAR WORD BEPAAL** deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Uitleg van sekere verwysings na petisieverrigtings.

1. Vanaf die inwerkingtreding van hierdie Wet word 'n verwysing in enige wet na die instel van aansoekverrigtings in 'n hof by wyse van petisie, uitgelê as 'n verwysing na die instel van sodanige verrigtings by wyse van kennisgewing van mosie ingevolge die reëls waarby die verrigtings van daardie hof gereël word.

Kort titel en inwerkingtreding.

2. Hierdie Wet heet die Wet op die Vervanging van Petisieverrigtings, 1976, en tree op 1 Julie 1976 in werking.

## PETITION PROCEEDINGS REPLACEMENT ACT, 1976.

Act No. 35, 1976

# ACT

To provide for the replacement of petition proceedings in courts of law.

*(English text signed by the State President.)*  
*(Assented to 19 March 1976.)*

**BE IT ENACTED** by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:-

1. As from the commencement of this Act any reference in any law to the institution of application proceedings in any court by petition, shall be construed as a reference to the institution of such proceedings by notice of motion in terms of the rules regulating the conduct of the proceedings of such court.

Construction of certain references to petition proceedings.

2. This Act shall be called the Petition Proceedings Replacement Act, 1976, and shall come into operation on 1 July 1976.
