Act No. 36, 1976

# ACT

**To repeal certain laws in force in the various provinces of the Republic; and to provide for incidental matters.**

*(Afrikaans text signed by the State President.)  
(Assented to 19 March 1976.)*

**BE IT ENACTED** by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. The laws specified in the Schedule are hereby repealed to the extent set out in the third column of the Schedule.
2. This Act shall be called the Pre-Union Statute Law Revision Act, 1976.
