PROCLAMATION

by the State President of the Republic of
South Africa

No. 72, 1976

EERSTE RIVER GOVERNMENT WATER CONTROL
AREA, DISTRICTS OF WYNBERG, STELLENBOSCH
AND SOMERSET WEST, CAPE PROVINCE.—INCLU-
SION OF CERTAIN AREA

Whereas the area comprising the Eerste River Govern-
ment Water Control Area has been defined by Proclama-
tion 146 of 1974;

And whereas the State President may, in terms of
section 59 (1) of the Water Act, 1956 (Act 54 of 1956),
by proclamation in the *Gazette*, declare an area com-
prising every piece of land which is affected or likely to
be affected by a Government water work or within which
the abstraction, utilisation, supply or distribution of the
water of any public stream should in his opinion be con-
trolled in the public interest, to be a Government water
control area, and may from time to time in like manner
amend such proclamation;

And whereas it is deemed necessary to include a certain
area in the said Government water control area;

Now, therefore, under and by virtue of the powers
vested in me by the said section 59 (1), I do hereby declare
that, with effect from the date of publication hereof, the
area described in the Schedule hereto shall for the pur-
poses of section 59 (1) (a) and (b) of the said Act be
included in the said Government water control area.
