Wet No. 61, 1976 WYSIGINGSWET OP DIE PARLEMENTÈRE EN PROVINSIALE MEDIESE HULPSKEMA, 1976

WET

Tot wysiging van die bepalings van die Wet op die Parlementêre en Provinciale Mediese Hulpskema, 1975, ten einde voorsiening te maak vir verpligte lidmaatskap van die Parmed Mediese Hulpskema van regters van die Hooggereghof van Suid-Afrika; en om vir bykomstige aangeleenthede voorsiening te maak.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 1 van die Wet op die Parlementêre en Provinciale Mediese Hulpskema, 1975, word hierby deur die volgende artikel vervang:

- „Verpligte lidmaatskap van Parmed Mediese Hulpskema van sekere persone.” **1. Elke persoon wat—**
- (a) terwyl hy nie 'n lid van of die Senaat of die Volksraad is nie, 'n Minister of 'n Adjunk-minister;
 - (b) 'n Administrateur van 'n provinsie of die Administrateur van die gebied Suidwes-Afrika;
 - (c) in 'n permanente hoedanigheid 'n regter van die Hooggereghof van Suid-Afrika;
 - (d) 'n lid van die Senaat, van die Volksraad, van die provinciale raad van 'n provinsie of van die Wetgewende Vergadering van die gebied Suidwes-Afrika;
 - (e) terwyl hy nie 'n lid van 'n provinciale raad is nie 'n lid van die uitvoerende komitee van 'n provinsie of, terwyl hy nie 'n lid van die Wetgewende Vergadering van die gebied Suidwes-Afrika is nie, 'n lid van die Uitvoerende Komitee van gemelde gebied, is of word, is 'n lid van die Parmed Mediese Hulpskema, behoudens die reëls van daardie mediese hulpskema soos geregistreer ooreenkomsdig die bepalings van die Wet op Mediese Skemas, 1967 (Wet No. 72 van 1967), solank hy daardie amp of pos beklee.”.

- 2.** Hierdie Wet heet die Wysigingswet op die Parlementêre en Provinciale Mediese Hulpskema, 1976, en word geag op 1 April 1976 in werking te getree het.

PARLIAMENTARY AND PROVINCIAL MEDICAL AID SCHEME Act No. 61, 1976
AMENDMENT ACT, 1976

ACT

To amend the provisions of the Parliamentary and Provincial Medical Aid Scheme Act, 1975, in order to provide for compulsory membership of the Parmed Medical Aid Scheme of judges of the Supreme Court of South Africa; and to provide for incidental matters.

(Assented to 4 May 1976.)

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. The following section is hereby substituted for section 1 of Substitution of the Parliamentary and Provincial Medical Aid Scheme Act, section 1 of Act 28 of 1975:

"Compulsory membership of Parmed Medical Aid Scheme of certain persons. (a) Every person who is or becomes—
(b) while not being a member of either the Senate or the House of Assembly, a Minister or Deputy Minister;
(c) an Administrator of a province or the Administrator of the territory of South West Africa;
(d) a judge of the Supreme Court of South Africa in a permanent capacity;
(e) a member of the Senate, of the House of Assembly, of the provincial council of a province or of the Legislative Assembly of the territory of South West Africa;
(f) while not being a member of a provincial council, a member of the executive committee of a province or, while not being a member of the Legislative Assembly of the territory of South West Africa, a member of the Executive Committee of the said territory,
shall, for as long as he holds that office or post, be a member of the Parmed Medical Aid Scheme, subject to the rules of that medical aid scheme as registered in accordance with the provisions of the Medical Schemes Act, 1967 (Act No. 72 of 1967).".

2. This Act shall be called the Parliamentary and Provincial Medical Aid Scheme Amendment Act, 1976, and shall be commencement deemed to have come into operation on 1 April 1976.
