Hierby word bekend gemaak dat die Staatspresident sy goedkeuring geheg het aan die onderstaande Wet wat hierby ter algemene inligting gepubliseer word:—

Wet No. 75, 1976**WYSIGINGSWET OP BESOLDIGING EN PENSIOENE VAN REGTERS, 1976****REPUBLIC OF SOUTH AFRICA****WET**

Tot wysiging van die Wet op Besoldiging en Pensioene van Regters, 1975, ten einde die pensioene aan die weduwees van regters van die Hooggereghof van Suid-Afrika betaalbaar, die salaris aan sodanige regters betaalbaar, en die pensioene na aftrede of ontheffing van amp aan sodanige regters betaalbaar, te verhoog; en om voorsiening te maak vir bykomstige aangeleenthede.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 12 van Wet 14 van 1975.

1. Artikel 12 van die Wet op Besoldiging en Pensioene van Regters, 1975 (hieronder die Hoofwet genoem), word hierby gewysig—

(a) deur subartikel (1) deur die volgende subartikel te vervang:

„(1) Aan die weduwee van 'n regter wat bygedra het en wat voor 1 April 1972 te sterwe gekom het of van iemand wat bygedra het en wat voor daardie datum as regter afgetree het of van sy amp as regter onthef is en voor 1 Julie 1974 te sterwe gekom het, word daar 'n pensioen van R3 960 per jaar betaal.”; en

(b) deur subartikel (2) deur die volgende subartikel te vervang:

„(2) By die dood op of na 1 April 1972 van iemand wat bygedra het, uitgesonderd iemand wat voor 1 April 1972 as regter afgetree het of van sy amp as regter onthef is en voor 1 Julie 1974 te sterwe gekom het, word daar aan sy weduwee 'n pensioen betaal van R2 563 per jaar, tesame met R256,30 per jaar ten opsigte van elke voltooide jaar van sy pensioengewende diens: Met dien verstande dat die pensioen waarop so 'n weduwee kragtens hierdie artikel geregty is, nie minder as R3 960 en nie meer as R5 126 per jaar bedra nie.”.

JUDGES' REMUNERATION AND PENSIONS AMENDMENT ACT, 1976 Act No. 75, 1976

ACT

To amend the Judges' Remuneration and Pensions Act, 1975, so as to increase the pensions payable to the widows of judges of the Supreme Court of South Africa, the salaries payable to such judges, and the pensions payable to such judges after retirement or removal from office; and to provide for incidental matters.

(English text signed by the State President.)

(Assented to 1 June 1976.)

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 12 of the Judges' Remuneration and Pensions Amendment of Act, 1975 (hereinafter referred to as the principal Act), is section 12 of hereby amended— Act 14 of 1975.

(a) by the substitution for subsection (1) of the following subsection:

“(1) To the widow of any judge who contributed and who died before 1 April 1972 or of any person who contributed and who retired as judge or was removed from his office as judge before that date and died before 1 July 1974 there shall be paid a pension of R3 960 per annum.”; and

(b) by the substitution for subsection (2) of the following subsection:

“(2) On the death on or after 1 April 1972 of any person who contributed, other than any person who retired as judge or was removed from his office as judge before 1 April 1972 and died before 1 July 1974, there shall be paid to his widow a pension of R2 563 per annum, together with R256,30 per annum in respect of each completed year of the pensionable service of such person: Provided that the pension to which such widow shall be entitled under this section shall amount to not less than R3 960 and to not more than R5 126 per annum.”.

JUDGES' REMUNERATION AND PENSIONS AMENDMENT Act No. 75, 1976
ACT, 1976

3. Schedule 2 to the principal Act is hereby amended by the Amendment of substitution for paragraphs 2 and 3 of the following paragraphs: Schedule 2 to Act 14 of 1975.

"2. Any pension calculated in accordance with paragraph 3 shall be subject to a minimum of R7 920 per annum.

(b) 1 April 1964 to 31 December 1970	(i) The basic pension, but not exceeding 60% of the annual salary; plus (ii) 51,8% of the amount referred to in item (i).
(c) 1 January 1971 to 31 March 1972	(i) The basic pension, but not exceeding 60% of the annual salary; plus (ii) 26,5% of the amount referred to in item (i).
(d) 1 April 1972 to 30 June 1974	(i) The basic pension, but not exceeding 80% of the annual salary; plus (ii) 26,5% of the amount referred to in item (i).
(e) 1 July 1974 to 30 June 1976 .	(i) The basic pension, but not exceeding 80% of the annual salary; plus (ii) 10% of the amount referred to in item (i). The basic pension, but not exceeding 80% of the annual salary.".
(f) From 1 July 1976	

4. (1) This Act shall be called the Judges' Remuneration and Pensions Amendment Act, 1976. **Short title and commencement.**

(2) Sections 1 and 3 shall come into operation on 1 October 1976 and section 2 on 1 July 1976.
