# PRIVATE ACT

To amend the University of Cape Town Act, 1959.

*(Afrikaans text signed by the State President.)*  
*(Assented to 2 March 1977.)*

Preamble.

**W**HEREAS for the better administration and conduct of the University of Cape Town it is expedient to amend the University of Cape Town Act, 1959 (Act No. 38 of 1959) (hereinafter referred to as the principal Act), so as to repeal the provision relating to the dismissal from their office of members of the teaching staff:

**B**E IT THEREFORE ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 11 of the principal Act is hereby amended by the deletion of subsection (3).

Short title.

2. This Act shall be called the University of Cape Town (Private) Amendment Act, 1977.
