No. 14 of 1977: Abuse of Dependence-producing Substances and Rehabilitation Centres Amendment Act, 1977.

Act No. 14, 1977ABUSE OF DEPENDENCE-PRODUCING SUBSTANCES AND
REHABILITATION CENTRES AMENDMENT ACT, 1977.

ACT

To amend the provisions of the Abuse of Dependence-producing Substances and Rehabilitation Centres Act, 1971, relating to definitions; to repeal section 4A of the said Act; and to substitute the words "social worker" for the words "social welfare officer" wherever they occur in the said Act.

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Short title.

- 1.** Section 1 of the Abuse of Dependence-producing Substances and Rehabilitation Centres Act, 1971 (hereinafter referred to as the principal Act), is hereby amended—
 - (a) by the insertion after the definition of "sell" of the following definition:
"social worker" means a person registered as a social worker under section 33 of the National Welfare Act, 1965 (Act No. 79 of 1965), and who is in the employ of the State or, for the purposes of sections 29 (1), 29 (2) (a), 30 (4) (a), 31 (1) (a), 31 (2), 31 (3) and 41 (2) only, a welfare organization registered under section 19 of the said Act;";
 - (b) by the deletion of the definition of "social welfare officer".
- 2.** Section 4A of the principal Act is hereby repealed.
- 3.** The principal Act is hereby amended by the substitution for the words "social welfare officer" wherever they occur in sections 27, 29, 30, 31, 41, 42, 43 and 44, of the words "social worker".
- 4.** This Act shall be called the Abuse of Dependence-producing Substances and Rehabilitation Centres Amendment Act, 1977.

WYSIGINGSWET OP DIE MISBRUIK VAN AFHANKLIKHEIDS-VORMENDE STOWWE EN REHABILITASIESENTRUMS, 1977.

Wet No. 14, 1977

WET

Tot wysiging van die bepalings van die Wet op die Misbruik van Afhanklikheidsvormende Stowwe en Rehabilitasiesentrums, 1971, betreffende woordomskrywings; om artikel 4A van bedoelde Wet te herroep; en om die woord „volkswelsynbeampte” waar dit ook al in bedoelde Wet voorkom, te vervang deur die woorde „maatskaplike werker”.

(Goedgekeur op 8 Maart 1977.)

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 1 van die Wet op die Misbruik van Afhanklikheids-vormende Stowwe en Rehabilitasiesentrums, 1971 (hieronder die Hoofwet genoem), word hierby gewysig—

- (a) deur die volgende omskrywing na die omskrywing van „landdros” in te voeg:
„maatskaplike werker” iemand wat ingevolge artikel 33 van die Nasionale Welsynswet, 1965 (Wet No. 79 van 1965), as maatskaplike werker geregistreer is en in diens is van die Staat of, by die toepassing van artikels 29 (1), 29 (2) (a), 30 (4) (a), 31 (1) (a), 31 (2), 31 (3) en 41 (2) alleen, ’n welsynorganisasie wat kragtens artikel 19 van bedoelde Wet geregistreer is.”;
- (b) deur die omskrywing van „volkswelsynbeampte” te skrap.

Wysiging van artikel 1 van Wet 41 van 1971, soos gewysig deur artikel 1 van Wet 80 van 1973.

2. Artikel 4A van die Hoofwet word hierby herroep.

Herroeping van artikel 4A van Wet 41 van 1971, soos ingevoeg deur artikel 4 van Wet 80 van 1973.

3. Die Hoofwet word hierby gewysig deur die woorde „volkswelsynbeampte” waar dit in artikels 27, 29, 30, 31, 41, 42, 43 en 44 voorkom, deur die woorde „maatskaplike werker” te vervang.

Vervanging van „volkswelsynbeampte” deur „maatskaplike werker” in artikels 27, 29, 30, 31, 41, 42, 43 en 44 van Wet 41 van 1971.

4. Hierdie Wet heet die Wysigingswet op die Misbruik van Kort titel Afhanklikheidsvormende Stowwe en Rehabilitasiesentrums, 1977.
