PRE-UNION STATUTE LAW REVISION ACT, 1977.

# ACT

**To repeal certain laws in force in the various provinces of, and in, the Republic; to amend the Pre-Union Statute Law Revision Act, 1968, so as to further regulate the reservation of rights in favour of the State; and to provide for incidental matters.**

*(Afrikaans text signed by the State President.)  
(Assented to 25 March 1977.)*

**B**E IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Repeal of laws.

**1.** The laws specified in the Schedule are hereby repealed to the extent set out in the third column of the Schedule.

Savings.

**2.** (1) Notwithstanding the repeal of "The Native Registered Voters Relief Act, 1887", of the province of the Cape of Good Hope by section 1, any person whose name is at the commencement of this Act included in the Cape Bantu voters' roll framed in terms of section 7 of the Representation of Bantu Act, 1936, shall retain all the rights and privileges to which he would, but for the repeal of the said repealed Act and any other laws have been entitled as a registered parliamentary voter in the province of the Cape of Good Hope.

(2) Notwithstanding the repeal of the "Harbour Lands Act, 1904", of the province of Natal by section 1, the agreement contained in the Schedule to the said Act, shall remain in force as if that Act had not been repealed.

**3.** The following section is hereby substituted for section 25 of the General Law Amendment Act, 1952:

"Doctrine of  
*laesio enor-*  
*mis* abolished  
in Republic.      **25.** No contract shall be void or voidable by reason merely of *laesio enormis* sustained by either of the parties to such contract."

**4.** Section 2 of the Pre-Union Statute Law Revision Act, 1968, is hereby amended by the addition of the following subsection, the existing section becoming subsection (1):

"(2) Notwithstanding the provisions of subsection (1), the repeal by section 1 of the Proclamation dated August 6, 1813, by Sir John Cradock, shall have, from the commencement of the Pre-Union Statute Law Revision Act, 1977, the effect of terminating any right reserved by that Proclamation of making and repairing public roads, and raising materials for that purpose, and any such right embodied in any title deed by virtue of such Proclamation only, shall from the said commencement be of no force and effect.".

**5.** This Act shall be called the Pre-Union Statute Law Revision Act, 1977.

**WET**

**Om sekere wette wat in die onderskeie provinsies van, en in, die Republiek van krag is, te herroep; om die Hersieningswet op Voor-Uniewette, 1968, te wysig ten einde die voorbehoud van regte ten gunste van die Staat verder te reël; en om vir bykomstige aangeleenthede voorsiening te maak.**

(Goedgekeur op 25 Maart 1977.)

**DAAR WORD BEPAAL** deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

**1.** Die wette in die Bylae vermeld, word hierby herroep in die Herroeping van mate in die derde kolom van die Bylae uiteengesit.

**2.** (1) Ondanks die herroeping van „The Native Registered Voter's Relief Act, 1887”, van die provinsie die Kaap die Goeie Hoop deur artikel 1, behou iemand wie se naam by die inwerkingtreding van hierdie Wet ingesluit is in die Kaapse Bantokieserslys opgestel ingevolge artikel 7 van die Bantoe-Verteenwoordigings-Wet, 1936, alle regte en voorregte waarop hy ingevolge die genoemde herroope Wet en enige ander wetsbepalings as geregistreerde parlementêre kieser in die provinsie die Kaap die Goeie Hoop geregtig sou gewees het indien daardie Wet nie herroep was nie.

(2) Ondanks die herroeping van die „Harbour Lands Act, 1904”, van die provinsie Natal deur artikel 1, bly die ooreenkoms in die Bylae tot die genoemde Wet vervat, van krag asof daardie Wet nie herroep was nie.

**3.** Artikel 25 van die Algemene Regswysigingswet, 1952, word hierby deur die volgende artikel vervang:

„Leerstuk van laesioenormis in Republiek afgeskaf.” **25.** Geen kontrak is nietig of vernietigbaar om rede slegs dat daar *laesioenormis* deur een of ander van die partye by so 'n kontrak verduur is nie.”

**4.** Artikel 2 van die Hersieningswet op Voor-Uniewette, 1968, word hierby gewysig deur die volgende subartikel by te voeg, terwyl die bestaande artikel subartikel (1) word:

„(2) Ondanks die bepalings van subartikel (1), het die herroeping deur artikel 1 van die Proklamasie van 6 Augustus 1813 deur Sir John Cradock, vanaf die inwerkingtreding van die Hersieningswet op Voor-Unie-Wette, 1977, die uitwerking dat enige reg wat deur daardie Proklamasie voorbehou is op die maak en instandhouding van openbare paaie en die gebruik van materiaal vir daardie doel, beëindig word, en enige sodanige reg beliggaam in enige titelakte uit hoofde van sodanige Proklamasie alleen, is vanaf bedoelde inwerkingtreding van nul en gener waarde.”
