GROUP AREAS AMENDMENT ACT, 1977.

## ACT

To amend the Group Areas Act, 1966, so as to extend the power of the Minister to establish local authorities under certain circumstances; and to exclude the application of certain provisions of the said Act in areas zoned for industrial purposes.

(Afrikaans text signed by the State President.) (Assented to 22 June 1977.)

**B**<sup>E</sup> IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Amendment of section 29 of Act 36 of 1966, as amended by section 3 of Act 22 of 1975. 1. Section 29 of the Group Areas Act, 1966 (hereinafter referred to as the principal Act), is hereby amended by the addition of the following subsection:

"(7) For the purposes of this section the area for which any consultative committee, management committee or local affairs committee has been established under any ordinance shall be deemed to be an area comprising an area for which a management committee has been established in terms of section 28."

Insertion of section 49A in Act 36 of 1966. 2. The following section is hereby inserted in the principal Act after section 49:

"Application of certain provisions in industrial areas. **49A.** Subject to the provisions of any other law, the provisions of sections 13, 14, 15, 17, 19, 20, 24, 25, 35, 37, 38, 39 and 40 shall not apply in an area zoned for industrial purposes in terms of any town planning scheme which is in operation or binding under any law."

Short title.

3. This Act shall be called the Group Areas Amendment Act, 1977.
