Act No. 110, 1977

APPROPRIATION ACT, 1977.

ACT

To appropriate an amount of money for the requirements of the State during the financial year ending 31 March 1978.

(Assented to 11 July 1977.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Appropriation of
R8 044 205 500 for
requirements of
State.

1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there is hereby appropriated for the requirements of the State during the financial year ending on 31 March 1978—

- (a) the amounts of money shown in column 1 of Schedule 1, with which the State Revenue Account shall be charged; and
- (b) the amounts of money shown in column 1 of Schedule 2, with which the South West Africa Account shall be charged.

Short title.

2. This Act shall be called the Appropriation Act, 1977.
