Act No. 127, 1977

UNIVERSITY OF THE WESTERN CAPE
AMENDMENT ACT, 1977.

ACT

To amend the University of the Western Cape Act, 1969, so as to further regulate the admission as students of persons not classified as members of the Cape Coloured, Malay, Griqua or Other Coloured Group; and to provide for incidental matters.

(Assented to 11 July 1977.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Repeal of
section 21 of
Act 50 of 1969.

1. Section 21 of the University of the Western Cape Act, 1969 (hereinafter referred to as the principal Act), is hereby repealed.

Substitution of
section 22 of
Act 50 of 1969.

2. The following section is hereby substituted for section 22 of the principal Act:

“Admission
as a student
of any
person not
classified
as a member
of a group
referred to
in section
2 (3).

22. Notwithstanding the provisions of subsection (3) of section 2 the council may, with the concurrence of the Minister and on the conditions determined by the Minister, approve the admission as a student of the University of any person not classified, as contemplated in that subsection, as a member of a group referred to in that subsection.”

Short title and
commencement.

3. This Act shall be called the University of the Western Cape Amendment Act, 1977, and shall come into operation on 1 January 1978.

WYSIGINGSWET OP DIE UNIVERSITEIT VAN

Tot wysiging van die Wet op die Universiteit van Wes-Kaapland, 1969, ten einde die toelating as studente van persone wat nie as lede van die Kaapse Kleurling-, Maleier- of Griekwa-groep of Groep Ander Gekleurdes geklassifiseer is nie, verder te reël; en om vir bykomstige aangeleenthede voorsiening te maak.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 21 van die Wet op die Universiteit van Wes-Kaapland, 1969 (hieronder die Hoofwet genoem), word hierby herroep. Herroeping van artikel 21 van Wet 50 van 1969.

2. Artikel 22 van die Hoofwet word hierby deur die volgende artikel vervang: Vervanging van artikel 22 van Wet 50 van 1969.

„Toelating as student van iemand wat nie as 'n lid van 'n in artikel 2 (3) bedoelde groep geklassifiseer is nie.

22. Ondanks die bepalings van subartikel (3) van artikel 2 kan die raad met die instemming van die Minister en op die voorwaardes wat die Minister bepaal, die toelating van iemand wat nie as 'n lid van 'n in daardie subartikel vermelde groep geklassifiseer is soos in daardie subartikel bedoel nie, as 'n student van die Universiteit goedkeur.”.

3. Hierdie Wet heet die Wysigingswet op die Universiteit van Wes-Kaapland, 1977, en tree op 1 Januarie 1978 in werking. Kort titel en inwerkingtreding.
