And whereas I have satisfied myself as to the relevant facts;

Now, therefore, under and by virtue of the powers and authority vested in me by section 39 of the Electoral Consolidation Act, 1946 (Act 46 of 1946), I hereby withdraw Proclamation 261 of 1977 in so far as it concerns the House of Assembly electoral division of Springs.
