1. Behoudens die bepalings van die Skatkis- en Ouditwet, 1975 (Wet No. 66 van 1975), word daar hierby vir die behoeftes van die Staat in die boekjaar wat op 31 Maart 1978 eindig, as 'n las teen die Staatsinkomsterekening, die addisionele bedrae geld uiteengesit in kolom 1 van die Bylae bewillig. 5

ACT

To appropriate an additional amount of money for the requirements of the State during the financial year ending 31 March 1978.

(Assented to 7 March 1978.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there is hereby appropriated for the requirements of the State during the financial year ending on 31 March 1978, as a charge to the State Revenue Account, the additional amounts of money shown in column 1 of the Schedule.

Appropriation of additional amount of money for requirements of State.

2. This Act shall be called the Additional Appropriation Act, 1978.
