1. Die bepalings van die Wet op Landelike Kleurlinggebiede, 1963, behalwe artikel 4 daarvan, word hierby herroep. 5

2. Hierdie Wet heet die Wysigingswet op Landelike Kleurlinggebiede, 1978, en tree in werking op 'n datum wat die Staatspresident by proklamasie in die *Staatskoerant* bepaal.

RURAL COLOURED AREAS
AMENDMENT ACT, 1978.

Act No. 31, 1978

ACT**To repeal certain provisions of the Rural Coloured Areas Act,
1963; and to provide for incidental matters.***(English text signed by the State President.)
(Assented to 14 March 1978.)***BE IT ENACTED** by the State President, the Senate and the
House of Assembly of the Republic of South Africa, as
follows:—

1. The provisions of the Rural Coloured Areas Act, 1963,
5 except section 4 thereof, are hereby repealed.
2. This Act shall be called the Rural Coloured Areas
Amendment Act, 1978, and shall come into operation on a date
fixed by the State President by proclamation in the *Gazette*.
