WYSIGINGSWET OP WINSBETREKKINGS

WET

Om aan sekere persone wat as lede van die Senaat of die Volksraad of 'n provinsiale raad verkies of benoem is of sitting geneem het of neem, tydelike vrystelling van die bepalinge van artikel 55 (d) van die Grondwet van die Republiek van Suid-Afrika, 1961, te verleen.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Artikel 55 (d) van Wet 32 van 1961 nie op sekere persone van toepassing nie.

1. Tot tyd en wyl by 'n wet anders bepaal word, maar nie later nie as 31 Mei 1979, is die bepalinge van artikel 55 (d) van die Grondwet van die Republiek van Suid-Afrika, 1961, nie van toepassing nie op iemand wat na 30 Mei 1974 as 'n lid van die Senaat of die Volksraad of 'n provinsiale raad verkies verklaar of benoem is of sitting geneem het of neem. 5

OFFICES OF PROFIT UNDER THE REPUBLIC
AMENDMENT ACT, 1978.

Act No. 54, 1978

ACT

To grant temporary exemption from the provisions of section 55 (d) of the Republic of South Africa Constitution Act, 1961, to certain persons who were elected or nominated or sat or sit as members of the Senate or the House of Assembly or a provincial council.

(Afrikaans text signed by the State President.)
(Assented to 12 April 1978.)

BE IT ENACTED by the State President, the Senate and the House of Assembly, of the Republic of South Africa, as follows:—

1. Until such time as is otherwise provided by any law, but not later than 31 May 1979, the provisions of section 55 (d) of the Republic of South Africa Constitution Act, 1961, shall not apply to any person who was declared elected or was nominated or sat or sits as a member of the Senate or the House of Assembly or a provincial council after 30 May 1974.
2. This Act shall be called the Offices of Profit under the Republic Amendment Act, 1978.

Section 55 (d) of Act 32 of 1961 not applicable to certain persons.
