Hierby word bekend gemaak dat die Staatspresident sy goedkeuring geheg het aan onderstaande Wet van die Verteenwoordigende Kleurlingraad van die Republiek van Suid-Afrika, wat hierby ter algemene inligting gepubliseer word:

LAW

To amend the provision of the Coloured Persons Rehabilitation Centres Law, 1971, relating to the definition of "social worker".

BE IT ENACTED by the Coloured Persons Representative Council of the Republic of South Africa, as follows:

Amendment of section 1 of Law 1 of 1971.

1. Section 1 of the Coloured Persons Rehabilitation Centres Law, 1971, is hereby amended by the substitution for paragraph (xxiii) of the following paragraph:

"'social worker' means a person registered as a social worker under section 33 of the National Welfare Act, 1965 (Act 79 of 1965), and who is in the employ of the State or, for the purposes of sections 14 (1), 14 (2) (a), 15 (4) (a), 16 (1) (a), 16 (2), 16 (3), 28 (2), 31 (1), 31 (2) (a) and 31 (3) only, a welfare organisation registered under section 19 of the said Act;"

Short title.

2. This Law shall be called the Coloured Persons Rehabilitation Centres Amendment Law, 1977.

Tot wysiging van die bepaling van die Wet op Rehabilitasiesentrums vir Kleurlinge, 1971, betreffende die woordskrywing van "maatskaplike werker".

DAAR WORD BEPAAL deur die Verteenwoordigende Kleurlingraad van die Republiek van Suid-Afrika, soos volg:

1. Artikel 1 van die Wet op Rehabilitasiesentrums vir Kleurlinge, 1971, word hierby gewysig deur paragraaf (xiv) deur die volgende paragraaf te vervang:

"'maatskaplike werker' iemand wat ingevolge artikel 33 van die Nasionale Welsynswet, 1965 (Wet 79 van 1965), as maatskaplike werker geregistreer is en in diens is van die Staat of, by die toepassing van artikels 14 (1), 14 (2) (a), 15 (4) (a), 16 (1) (a), 16 (2), 16 (3), 28 (2), 31 (1), 31 (2) (a) en 31 (3) alleen, 'n welsynsorganisasie wat kragtens artikel 19 van bedoelde Wet geregistreer is;"

2. Hierdie Wet heet die Wysigingswet op Rehabilitasiesentrums vir Kleurlinge, 1977.
