It is hereby notified that the State President has assented to the following Act which is hereby published for general information:—

No. 13 of 1979: Bethelsdorp Settlement Amendment Act, 1979.

Act No. 13, 1979**BETHELSDORP SETTLEMENT AMENDMENT ACT, 1979.****ACT**

To provide that the provisions of Part II of the Schedule to the Bethelsdorp Settlement Act, 1921, shall cease to apply with reference to certain land.

(Assented to 6 March 1979.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Part II of
Schedule to
Act 34 of 1921,
not to apply
in respect of
certain land.

Short title.

1. As from the date of commencement of this Act the provisions of Part II of the Schedule to the Bethelsdorp Settlement Act, 1921, shall cease to apply with reference to the land granted to the Divisional Council of Port Elizabeth by Crown Grant No. 148/1949 dated 15 August 1949.
2. This Act shall be called the Bethelsdorp Settlement Amendment Act, 1979.

5 bepalings van Deel II van die Bylae by die „Bethelsdorp Bylae by Wet 34 van 1921
Schikkingswet, 1921”, nie meer met betrekking tot die grond wat nie ten opsigte van
kragtens Kroongrondbrief No. 148/1949 gedateer 15 Augustus sekere grond van
1949 aan die Afdelingsraad van Port Elizabeth toegeken is van toepassing nie.
