It is hereby notified that the State President has assented to the following Act which is hereby published for general information:—

No. 15 of 1979: Additional Appropriation Act, 1979.

ACT

To appropriate an additional amount of money for the requirements of the State during the financial year ending 31 March 1979.

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Appropriation of

1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there is hereby appropriated for the requirements of the State during the financial year ending on 31 March 1979, as a charge to the State Revenue Account, the additional amounts of money shown in column 1 of the Schedule. 5

Short title.

2. This Act shall be called the Additional Appropriation Act, 1979. 10
