By direction of the Minister of Manpower Utilisation, it is hereby notified, in terms of section 15 (2) read with sections 15 (6) and 13 (1) (a) of the Wage Act, 1957, that the Minister proposes to amend the above Wage Determination in accordance with the recommendation of the Wage Board which appears in the Schedule hereto.

All persons whose interests may be affected directly or indirectly are hereby invited, should they have any objections to the amendment of the said Determination, to lodge such objections in writing, in ninefold, together with nine copies of all supporting documents, with the Director-General: Manpower Utilisation, Private Bag X117, Pretoria, 0001, within 30 days from the date of publication of this notice.

Transvaal.—The Magisterial Districts of Alberton, Benoni, Boksburg, Brakpan, Germiston, Johannesburg, Kempton Park, Krugersdorp, Nigel, Oberholzer, Pretoria, Randburg, Randfontein, Roodepoort, Springs, Vanderbijlpark, Vereeniging, Westonaria and Wonderboom;

Natal.—The Magisterial Districts of Durban, Inanda, Pietermaritzburg and Pinetown;

Orange Free State.—The municipal areas of Bloemfontein, Sasolburg and Welkom;

(ab) R550 per month in the following area:

Cape Province.—The Magisterial District of Stellenbosch;

(ac) R500 per month in any other area covered by the Determination...".
