EDUCATION AND TRAINING AMENDMENT ACT, 1981

## GENERAL EXPLANATORY NOTE:

- Words underlined with solid line indicate insertions in existing enactments.

**ACT**

To amend the Education and Training Act, 1979, so as to substitute a certain official title and to effect a certain textual alteration; and to provide for incidental matters.

(*English text signed by the State President.*)  
*(Assented to 10 February 1981.)*

**BE IT ENACTED** by the State President and the House of Assembly of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 90 of 1979, as amended by section 1 of Act 52 of 1980.

1. Section 1 of the Education and Training Act, 1979 (hereinafter referred to as the principal Act), is hereby amended—

- (a) by the insertion after the definition of “Department” of the following definition:  
**“Director-General” means the Director-General: Education and Training; and**

(b) by the deletion of the definition of “Secretary”. 10

Amendment of section 23 of Act 90 of 1979.

2. Section 23 of the principal Act is hereby amended—

- (a) by the substitution for paragraph (e) of subsection (23) of the following paragraph:  
**“(e) the person charged be discharged from the service of his employer or be called upon to resign therefrom [; or] and that he**

**[(f) the person charged] shall not be appointed as a teacher for a period (if any) determined by the Minister.”;** and

(b) by the deletion of paragraph (f) of subsection (23). 20

Substitution of word “Secretary” in Act 90 of 1979.

3. The principal Act is hereby amended by the substitution for the word “Secretary”, wherever it occurs, of the expression “Director-General”.

Short title.

4. This Act shall be called the Education and Training Amendment Act, 1981. 25

**WET**

Tot wysiging van die Wet op Onderwys en Opleiding, 1979, ten einde 'n sekere ampstiel te vervang en 'n sekere teksverandering aan te bring; en om vir bykomstige aangeleenthede voorsiening te maak.

(Goedgekeur op 10 Februarie 1981.)

**DAAR WORD BEPAAL** deur die Staatspresident en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 1 van die Wet op Onderwys en Opleiding, 1979 (hieronder die Hoofwet genoem), word hierby gewysig—  
5     (a) deur die volgende omskrywing na die omskrywing van „Departement” in te voeg:  
      „,Direkteur-generaal” die Direkteur-generaal: Onderwys en Opleiding;”; en  
      (b) deur die omskrywing van „Sekretaris” te skrap.
- 10    2. Artikel 23 van die Hoofwet word hierby gewysig—  
      (a) deur paragraaf (e) van subartikel (23) deur die volgende paragraaf te vervang:  
          „(e) die aangeklaagde uit die diens van sy werkgewer ontslaan word of gelas word om daaruit te bedank [**; of**] en dat hy  
15     (f) die aangeklaagde] vir 'n tydperk (as daar is) wat die Minister bepaal, nie as 'n onderwyser aangeset mag word nie.”; en  
      (b) deur paragraaf (f) van subartikel (23) te skrap.
- 20    3. Die Hoofwet word hierby gewysig deur die woord Vervanging van „Sekretaris”, waar dit ook al voorkom, deur die uitdrukking woord „Sekretaris” in Wet 90 van 1979.  
      „Direkteur-generaal” te vervang.
4. Hierdie Wet heet die Wysigingswet op Onderwys en Kort titel. Opleiding, 1981.
