**REDEFINITION OF THE LOCAL LIMITS OF DIS-
TRICTS IN THE PROVINCE OF THE CAPE OF GOOD
HOPE AND MATTERS INCIDENTAL THERETO**

I, Pieter Gerhardus Jacobus Koornhof, Minister of Co-operation and Development, acting by virtue of the powers vested in me by section 2 (1) (c) and (1) of the Magistrates' Courts Act, 1944 (Act 32 of 1944), read with section 14 (3) of the National States Constitution Act, 1971 (Act 21 of 1971), hereby give notice that with effect from 4 September 1981, I—

(a) redefine the local limits of the Districts of Hewu, Victoria East, Keiskammahoek, Zwelitsha, Mdantsane, Middeldrift and Peddie in accordance with the accompanying Schedules A, B, C, D, E, F and G respectively; and

(b) amend Government Notices 1482 of 1971 and 1690 of 1971, Proclamation 21 of 1937 and the Proclamation by His Excellency the Administrator of the Government of the Cape of Good Hope of 8 March 1848 accordingly.

Beginning at the point where the eastern boundary of the farm Lammermoor 327, Administrative District of Queens-town, intersects the middle of the Swart Kei River; thence generally eastwards and south-eastwards along the middle of the said Swart Kei River to the point where it intersects the prolongation of the western boundary of the farm Botha's Hoek 364; thence generally southwards, eastwards and south-eastwards along the said prolongation and the boundaries of the following farms so as to exclude them from this area: The said Botha's Hoek 364, Merino 365,
