Act No. 64, 1981

ROAD TRANSPORTATION AMENDMENT ACT, 1981

GENERAL EXPLANATORY NOTE:

ACT

To amend the Road Transportation Act, 1977, so as to limit the concession in respect of the conveyance of exempted goods; and to provide for incidental matters.

(English text signed by the State President.)
(Assented to 25 August 1981.)

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 74 of 1977, as amended by section 1 of Act 93 of 1979 and section 1 of Act 91 of 1980.

1. Section 1 of the Road Transportation Act, 1977, is hereby amended by the substitution for paragraph (z) of subsection (2) of the following paragraph:

“(z) the conveyance **[by means of a motor vehicle]** of exempted goods, by means of a motor vehicle—”

(i) which is registered in the Republic under the law governing the registration of motor vehicles in force at that place;

(ii) whose owner is domiciled within the Republic; and

(iii) which is identified in the manner prescribed by regulation,

by any person who is domiciled in the Republic, or any company registered in the Republic, actively carrying on business from a place situated in the Republic:”

Short title.

2. This Act shall be called the Road Transportation Amendment Act, 1981.

WET

Tot wysiging van die Wet op Padvervoer, 1977, ten einde die toegewing ten opsigte van die vervoer van vrygestelde goedere te beperk; en om vir bykomstige aangeleenthede voorsiening te maak.

DAAR WORD BEPAAL deur die Staatspresident en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 1 van die Wet op Padvervoer, 1977, word hierby gewysig deur paragraaf (z) van subartikel (2) deur die volgende paragraaf te vervang:
- „(z) die vervoer **[deur middel van 'n motorvoertuig]** van vrygestelde goedere, deur middel van 'n motorvoertuig—
- (i) wat in die Republiek geregistreer is kragtens die wet op die registrasie van motorvoertuie wat op daardie plek geld;
- (ii) waarvan die eienaar in die Republiek gedomisileer is; en
- (iii) wat op die by regulasie voorgeskrewe wyse geïdentifiseer is,
- deur iemand wat in die Republiek gedomisileer is, of 'n maatskappy wat in die Republiek geregistreer is, wat daadwerklik besigheid dryf vanaf 'n plek in die Republiek geleë:”

Wysiging van artikel 1 van Wet 74 van 1977, soos gewysig deur artikel 1 van Wet 93 van 1979 en artikel 1 van Wet 91 van 1980.

2. Hierdie Wet heet die Wysigingswet op Padvervoer, 1981. Kort titel.
