(a) onbind hierby die Gemeenskapsraad van Kimberley, ingestel by Goewermentskennisgowing R. 1088, gedateer 2 Junie 1978, met ingang van die datum (hieronder onbindingsdatum genoem) van die eerste gewone vergadering van die Stadsraad van Galeshewe, ingestel by Goewermentskennisgowing 1959, gedateer 2 September 1983, vir die gebied van genoemde Gemeenskapsraad;

(b) verklaar hierby dat iets wat kragtens die Wet op Gemeenskapsrade, 1977 (Wet 125 van 1977), of 'n ander wet deur of ten opsigte van genoegende Gemeenskapsraad gedoen is en wat deur of ten opsigte van genoemde Stadsraad kragtens die Wet op Swart Plaaslike Besture, 1982, of sodanige ander wet gedoen kan word, met ingang van die onbindingsdatum geag word deur of ten opsigte van daardie Stadsraad gedoen te wees;

(c) verklaar hierby dat die bates, laste, regte en verpligte van genoemde Gemeenskapsraad op die onbindingsdatum op genoemde Stadsraad oorgaan;

(d) verklaar hierby dat iemand wat onmiddellik voor die onbindingsdatum 'n betrekking as 'n werknemer van genoemde Gemeenskapsraad beklee het, op die onbindingsdatum deur genoemde Stadsraad in 'n geskikte pos op sy diensstaat aangestel moet word behoudens die voorwaardes en teen die besoldiging van toepassing op die betrokke pos: Met dien verstande dat—

(i) genoemde voorwaardes (waarby ingesluit is verlof, siekteleof en pensioenvoordele) en besoldiging nie minder gunstig mag wees nie as die voorwaardes en besoldiging wat op hom van toepassing was in die diens van genoemde Gemeenskapsraad;

(ii) enige verlof, siekteleof en pensioenvoordele tot so iemand se krediet op die onbindingsdatum tot sy krediet moet bly by aanstelling deur genoemde Stadsraad;

### DISSOLUTION OF THE COMMUNITY COUNCIL OF KIMBERLEY

I, George de Viliers Morrison, Deputy Minister of Co-operation, acting on behalf of and by direction of the Minister of Co-operation and Development under and by virtue of the powers vested in him by section 4 of the Black Local Authorities Act, 1982 (Act 102 of 1982), hereby—

(a) dissolve the Community Council of Kimberley, established under Government Notice R. 1088, dated 2 June 1978, with effect from the date (hereinafter referred to as the dissolution date) of the first ordinary meeting of the Town Council of Galeshewe, established under Government Notice 1959, dated 2 September 1983, for the area of the said Community Council;

(b) declare that anything done under the Community Councils Act, 1977 (Act 125 of 1977), or any other law by or in respect of the said Community Council and which may be done by or in respect of the said Town Council under the Black Local Authorities Act, 1982, or such other law, shall, with effect from the dissolution date, be deemed to have been done by or in respect of that Town Council;

(c) declare that the assets, liabilities, rights and obligations of the said Community Council shall, on the dissolution date devolve upon the said Town Council;

(d) declare that any person who immediately before the dissolution date held an appointment as an employee of the said Community Council shall, on the dissolution date, be appointed by the said Town Council to an appropriate post on its establishment on the conditions and at the remuneration applicable to the said post: Provided that—

(i) the said conditions (including leave, sick leave and pension benefits) and remuneration shall not be less favourable than the conditions and remuneration which applied to him while he was in the service of the said Community Council;

(ii) any leave, sick leave and pension benefits standing to such person's credit on the dissolution date shall remain to his credit on appointment by the said Town Council;

(e) amend with effect from the dissolution date the schedule to Government Notice R. 1088, dated 2 June 1978, by the deletion of the expressions "Kimberley (Galeshewe)" and "580 of 5 April 1974".

(d) verklaar hierby dat iemand wat onmiddellik voor die ontbindingsdatum 'n aanstelling as 'n werknemer van enige van genoemde gemeenskapsrade gehou het, word, vanaf genoemde ontbindingsdatum, aangestel in 'n pos wat by die betrokke plaaslike bestuur ingestel is op die voorwaardes wat vir daardie pos voorgeskryf is en teen die besoldiging wat vir daardie pos bepaal is: Met dien verstande dat—

(i) bedoelde voorwaardes (waarby ingesluit is verlof, siektelelof en pensioenvoordele) en besoldiging nie minder gunstig mag wees as die voorwaardes en besoldiging wat op hom van toepassing was as 'n persoon in diens van genoemde gemeenskapsraad nie; en

**DISSOLUTION OF CERTAIN  
COMMUNITY COUNCILS**

**I, George de Villiers Morrison, Deputy Minister of Co-operation, acting on behalf of and by direction of the Minister of Co-operation and Development under and by virtue of the powers vested in him by section 4 of the Black Local Authorities Act, 1982 (Act 102 of 1982), hereby—**

(a) dissolve each community council mentioned in the first column of Schedule I as from the date (hereinafter referred to as the dissolution date) of the first ordinary meeting of the local authority mentioned opposite each such community council in the third column of the said Schedule;

(b) declare that anything done under the Community Councils Act, 1977 (Act 125 of 1977), or any other law by or in respect of any one of the said community councils and which may be done by or in respect of a local authority under the Black Local Authorities Act, 1982, or such other law, shall, with effect from the dissolution date, be deemed to have been done by or in respect of the local authority concerned;

(c) declare that the assets, liabilities, rights and obligations of each of the said community councils shall, on the dissolution date, devolve upon the local authority concerned;

(d) declare that any person who immediately before the dissolution date held an appointment as an employee of any of the said community councils shall, as from the said dissolution date, be appointed to a post established under the local authority concerned on such conditions as may be prescribed for such post and at such remuneration as may be determined for such post: Provided that—

(i) the said conditions (including leave, sick leave and pension benefits) and remuneration shall not be less favourable than the conditions and remuneration which applied to him as a person employed by the said community council; and

(ii) any leave, sick leave and pension benefits standing to such person's credit on the dissolution date shall be deemed to be earned by him in the service of such local authority;

(e) with effect from the said dissolution date repeal or amend the Government Notices mentioned in the second column opposite the community councils mentioned in the first column of Schedule II to the extent set out in the third column thereof.
