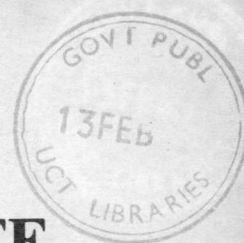

Kragtens die bevoegdheid my verleen by artikel 9A van die Waterwet, 1956 en bykomstig tot die beperkings ingestel in paragraaf 8 (a) van die Bylae tot Algemene Kennisgewing 143 van 27 Januarie 1984, verbied ek Sarel Antoine Strydom Hayward in my hoedanigheid van Minister van Omgewingsake en Visserye hierby die onttrekking van water uit die Umgeni-rivier vir die opwekking van hidro-elektriese krag.

Kragtens die bevoegdheid my verleen by artikel 165 van die genoemde Wet dra ek hierby die bevoegdheid oor aan die Seksie-ingenieur (Natal) om by skriftelike kennisgewing aan enige gebruiker van sodanige water vir die genoemde doeleindes, met inagneming van 'n verbetering in die vloei van water in die Umgeni-rivier en die hoeveelheid water beskikbaar in die Albert Fallsdam, die hierby ingestelde verbod tydelik op te hef onderworpe aan die voorwaardes wat hy bepaal of die verbod onbepaald op te hef in welke geval hierdie Kennisgewing geag word deur my herroep te wees.

NOTICE IN TERMS OF SECTION 9A OF THE
WATER ACT, 1956PROHIBITION ON THE ABSTRACTION OF WATER
FROM THE UMGENI RIVER FOR USE FOR CERTAIN
INDUSTRIAL PURPOSES

By virtue of the powers vested in me by section 9A of the Water Act, 1956 and in addition to the restrictions imposed in paragraph 8 (a) of the Schedule to General Notice 143 of 27 January 1984, I Sarel Antoine Strydom Hayward hereby in my capacity as Minister of Environment Affairs and Fisheries prohibits completely the abstraction of water from the Umgeni River for the generation of hydro-electric power.

By virtue of the powers vested in me by section 165 of the said Act I hereby delegate to the Circle Engineer (Natal) the power to by notice in writing to any user of such water for the said purposes, and with due regard to an improvement in the flow of water in the Umgeni River and the quantity of water available in the Albert Falls Dam, temporarily raise the prohibition hereby imposed, subject to the conditions determined by him or to raise the prohibition indefinitely in which case this Notice shall be deemed to have been revoked by me.
