DRAF BY-LAW.—ELECTRICITY LEVY SUPPLEMENTARY TO SITE RENTAL AND HOSTEL FEES

It is hereby notified in terms of Government Notice R. 1993, dated 16 September 1983, that the Council proposes to make the following By-law:

Sites	Present tariff	New tariff
(a) Residential sites and all other sites not mentioned in paragraphs (b) and (c)	R6 per site per month	R10 per site per month.
(b) Hostel.....	R3 per bed per month	R4 per bed per month.
(c) Business sites (including beer halls and liquor stores)	R40 per site per month	R60 per site per month.

Die algemene strekking van die Verordening is soos volg:

Om die Elektrisiteitsheffing Aanvullend tot Perseelhuur en Hosteltariewe te verhoog ten einde die addisionele uitgawe wat deur die implimentering van die Elektrisiteits-meesterplan veroorsaak is, te bestry.

To increase the Electricity Levy Supplementary to Site Rental and Hostel Fees to defray the additional expenses caused by the implementation of the Electricity Master Plan.
