behoeftes van die Departement van Pos- en Telekommunikasie-
wese, soos nader uiteengesit in die Begroting van Addisionele
Uitgawe van daardie departement vir genoemde boekjaar [R.P.
10—1984], soos aan die Parlement voorgelê en deur hom goed- 10
gekeur.

ooruitgawe op 'n bedrag wat by die Poskantoorbegrotingswet,
1983 (Wet No. 26 van 1983), vir 'n doel in artikel 3 van laasge-
noemde Wet vermeld, bewillig is nie.

ADDITIONAL POST OFFICE APPROPRIATION ACT, 1984

Act No. 22, 1984

ACT

To appropriate an additional sum of money for the requirements of the Department of Posts and Telecommunications in respect of the financial year ending 31 March 1984.

*(Afrikaans text signed by the State President.)
(Assented to 24 February 1984.)*

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

1. Subject to the provisions of the Post Office Act, 1958 (Act No. 44 of 1958), an additional amount of R175 955 000 is hereby appropriated in respect of the financial year ending 31 March 1984, as a charge to the Post Office Fund, for the requirements of the Department of Posts and Telecommunications, as more particularly specified in the Estimates of Additional Expenditure of that department for the said financial year [R.P. 10—1984], as submitted to and approved by Parliament.

Appropriation of additional moneys for requirements of Department.

2. Notwithstanding the provisions of section 12F (3) and (4) of the Post Office Act, 1958, no saving on an amount appropriated by this Act for any purpose may be utilized, otherwise than in accordance with an authority granted under section 12F (5) (a) of the said Act, for defraying excess expenditure on any amount appropriated by the Post Office Appropriation Act, 1983 (Act No. 26 of 1983), for any purpose mentioned in section 3 of the latter Act.

Restriction on utilization of savings.

3. This Act shall be called the Additional Post Office Appropriation Act, 1984. Short title.
