It is hereby notified that the State President has assented to the following Act which is hereby published for general information:—

No. 25 van 1984: Wysigingswet op Staatsdorpe, 1984.

No. 25 of 1984: Government Villages Amendment Act, 1984.

GENERAL EXPLANATORY NOTE:

ACT

To amend the Government Villages Act, 1973, so as to provide for the exclusion of a Government Village or portion of a Government Village from the application of the said Act; to authorize the Director-General: Community Development to delegate powers conferred upon him by the said Act; and to substitute or delete certain obsolete designations; and to provide for incidental matters.

(Assented to 29 February 1984.)

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 1 of the Government Villages Act, 1973 (hereinafter referred to as the principal Act), is hereby amended—
- 5 (a) by the insertion before the definition of "Government Villages" of the following definition:
 "'Director-General' means the Director-General: Community Development;";
- 10 (b) by the substitution for the definition of "Government Villages" of the following definition:
 "'Government Villages' means, except in so far as excluded under section 2A from the application of this Act, the former military camps used for residential purposes and situated at Benoni, Germiston, Randfontein, Vereeniging, Cradock Place (Port Elizabeth), Collondale (East London) and Oribi (Pietermaritzburg);";
- 15 (c) by the substitution in the Afrikaans text for the definition of "Minister" of the following definition:
 "'Minister' die Minister van [Gemeenskapsbou] Gemeenskapsontwikkeling;"; and
- 20 (d) by the deletion of the definition of "Secretary".
2. The following section is hereby inserted in the principal Act after section 2:
- 25 "Exclusion of Government Villages from application of Act. 2A. The Minister may by notice in the Gazette exclude from the application of this Act any Government Village or any portion of a Government Village specified in the notice."
3. The following section is hereby inserted in the principal Act after section 4:
- 30 "Delegation of powers. 4A. (1) The Director-General may delegate any power conferred upon him by this Act to any officer in the public service."

GOVERNMENT VILLAGES AMENDMENT ACT, 1984

Act No. 25, 1984

(2) A delegation under subsection (1) shall not prevent the exercise of the relevant power by the Director-General himself, and may at any time be withdrawn by the Director-General.”

- 5 4. The principal Act is hereby amended by the substitution for the expression “Secretary”, wherever it occurs, of the expression “Director-General”. Substitution of certain designation in Act 44 of 1973.
5. This Act shall be called the Government Villages Amendment Act, 1984. Short title.
