VERBOD OP DIE VERDERE OPGARING VAN OPENBARE WATER IN EN INKORTING VAN DIE GEBRUIK VIR BESPROEINGSDOELEINDES EN ANDER LANDBOUDOELEINDES, VAN OPENBARE WATER UIT DIE VAALRIVIER EN AL SY SYTAKKE

1. Bykomstig tot die maatreëls uiteengesit in Algemene Kennisgewing 556 van 22 Julie 1983 soos aangevul en gewysig deur Algemene Kennisgewings 91 van 3 Februarie 1984 en 116 van 14 Februarie 1984 met betrekking tot die gebruik van water uit die genoemde riviere tot 31 Maart 1984 en ten einde besproeiërs in staat te stel om hul bedrywighede betyds te beplan in ooreenstemming met die maatreëls wat hierby getref word in die verwagting dat die heersende watertekort gedurende die tydperk 1 April 1984 tot 30 September 1984 gaan voortduur, verklaar, verbied en stel ek, Sarel Antoine Strydom Hayward, in my hoedanigheid van Minister van Omgewingsake en Visserie, kragtens die bevoegdheid my verleen by artikel 9A van die Waterwet, 1956, hierby in—

(a) dat 'n watertekort waarskynlik gedurende die tydperk 1 April 1984 tot 30 September 1984 ondervind sal word in die Vaalrivier en al sy sytakke vanaf hul onderskeie oorspronge tot die samevloeiing van die Vaal en die Oranjerivier;

(b) die opgaring gedurende die genoemde tydperk van water deur private persone in die bedding van enige van die genoemde riviere; en

(c) gedurende die genoemde tydperk, die maatreëls uiteengesit in die Bylae hiertoe, wat daarop gemik is om die gebruik van water vir besproeiingsdoeleindes uit enige van die genoemde riviere in te kort tot die mate in die Bylae uiteengesit.

2. Ek deleger hierby kragtens artikel 165 van die genoemde Wet aan die Hoofingenieur (Besproeiingskemas en Ingenieursdienste), die bevoegdheid om by kennisgewing in die *Staatskoerant*—

(a) in sy diskresie die bepalinge van die Bylae tot hierdie kennisgewing in die algemeen of ten opsigte van enige besondere persoon te wysig ten einde met inagneming van plaaslike omstandighede, die verlangde inkorting te bewerkstellig; of

(b) met inagneming van 'n verswakking of verbetering in die beskikbaarheid van water in die genoemde riviere—

(i) die beoogde inkorting uit te brei of te verslap of, na gelang van die geval, dit onbepaald op te hef, in welke geval hierdie kennisgewing geag word deur my ingetrek te wees; of

(ii) tydelik die verbod op te verdere opgaring van water bedoel in paragraaf 1 (b) op te hef; of

(iii) tydelik die bedryf oor te neem van enige waterwerk in private besit deur middel waarvan water waarop hierdie kennisgewing betrekking het, uitgeneem, opgedam, opgegaar, voorsien of vir besproeiingsdoeleindes gebruik word en om sodanige waterwerk te laat bedryf deur enige persoon wat skriftelik deur hom aangewys is, ooreenkomstig sy voorskrifte.

GENERAL NOTICES**NOTICE 183 OF 1984****DEPARTMENT OF ENVIRONMENT AFFAIRS****NOTICE IN TERMS OF SECTION 9A OF THE WATER ACT, 1956**

PROHIBITION ON THE FURTHER STORAGE OF PUBLIC WATER IN AND CURTAILMENT OF THE USE FOR IRRIGATION PURPOSES AND OTHER AGRICULTURAL PURPOSES OF PUBLIC WATER FROM THE VAAL RIVER AND ALL ITS TRIBUTARIES

1. In addition to the measures set out in General Notice 556 of 22 July 1983 as supplemented and amended by General Notices 91 of 3 February 1984 and 116 of 14 February 1984 relating to the use for irrigation purposes of water from the said rivers up to 31 March 1984, and in order to enable irrigators to plan their activities beforehand in accordance with the measures set out in the Schedule to this notice which are hereby prescribed in the expectation that the existing water shortage will continue during the period 1 April 1984 to 30 September 1984, I, Sarel Antoine Strydom Hayward, in my capacity as Minister of Environment Affairs and Fisheries, by virtue of the powers vested in me by section 9A of the Water Act, 1956—

(a) hereby declare that a water shortage is expected during the period 1 April 1984 to 30 September 1984 in the Vaal River and all its tributaries from their respective sources to the confluence of the Vaal River and the Orange River;

(b) I hereby prohibit during the said period the storage by private individuals of any water in the bed of any of the said rivers; and

(c) I hereby impose during the said period the measures set out in the Schedule hereto which are aimed at reducing the use for irrigation purposes of water from any of the said rivers to the extent set out in the said Schedule.

2. I hereby delegate in terms of section 165 of the said Act to the Chief Engineer: Irrigation and Engineering Services, the power to, by notice in the *Gazette*—

(a) amend in his discretion the provisions of the Schedule to this notice in general or in respect of any particular person in order to accomplish, with due regard to local conditions, the required curtailment; or

(b) with due regard to a deterioration or improvement in the availability of water in the said rivers—

(i) extend or relax the envisaged curtailment or, as the case may be, to lift it indefinitely, in which case this notice shall be deemed to have been revoked by me; or

(ii) temporarily raise the prohibition referred to in paragraph 1 (b) on the further storage of water; or

(iii) temporarily take over the operation of any privately owned water work by means of which water to which this notice applies, is abstracted, impounded, stored, supplied or used for irrigation purposes and to cause the operation of such water work to be undertaken in accordance with his directions by any person directed thereto in writing by him.

BYLAE

A. MOOIRIVIER EN SCHOONSPRUIT

Die maatreëls ingestel by Algemene Kennisgewing 91 van 3 Februarie 1984 is van toepassing.

B. VAALRIVIER VANAF VAALDAM STROOM AF TOT DIE SAMEVLOEING MET DIE ORANJE-RIVIER

(1) Water voorsien uit of deur middel van Staatswaterwerke uit die bogenoemde rivier word gedurende die tydperk 1 April 1984 tot 30 September 1984 beperk tot 800 kubieke meter ten opsigte van elke hektaar grond wat ingevolge artikel 63 van die Waterwet, 1956, ingelys is.

(2) Die onttrekking deur middel van private waterwerke van water vir besproeiingsdoeleindes uit die genoemde rivier kragtens enige bepaling van die Vaalrivier Uitbreidingskema Wet, 1934, of die Waterwet, 1956, word gedurende dieselfde tydperk ingekort tot 10 persent van die hoeveelheid wat kragtens die genoemde Wette gedurende 'n besproeiingsjaar onttrek mag word.

(3) (a) Enige persoon wat kragtens die genoemde Wette daarop geregtig is om deur middel van waterwerke in private besit water vir besproeiingsdoeleindes uit die genoemde rivier te onttrek, moet voor 31 Maart 1984 by die Sektie-ingenieur (Vaalrivierseksie) Privaatsak X16, Kroonstad, 9500 (Telefoon 01411-24184), aansoek doen vir 'n magtiging wat die verminderde hoeveelheid water vermeld wat hy kragtens hierdie kennisgewing gedurende die genoemde tydperk uit die genoemde rivier mag onttrek, en behoudens paragraaf D, die ure van elke week waartydens sodanige onttrekking mag geskied.

(b) Niemand mag gedurende die tydperk 1 April 1984 tot 30 September 1984 deur middel van waterwerke in private besit water vir besproeiingsdoeleindes uit die genoemde gedeelte van die Vaalrivier onttrek nie, behalwe op gesag van 'n magtiging kragtens subparagraaf (3) (a) en in ooreenstemming met die voorskrifte van sodanige magtiging.

(c) Die Sektie-ingenieur (Vaalrivierseksie) kan te eniger tyd na skriftelike kennisgewing aan iemand aan wie 'n magtiging uitgereik is, die voorskrifte daarvan wysig indien hy van oordeel is dat die verlangde inkorting tot 10 persent nie oor die tydperk 1 April 1984 tot 30 September 1984 bereik sal word nie.

C. VAALRIVIER STROOM OP VAN VAALDAM EN AL SY SYTAKKE STROOM OP EN STROOM AF VAN VAALDAM BEHALWE DIE MOOIRIVIER, RHENOSTERRIVIER, SCHOONSPRUIT, VET-RIVIER, HARTSRIVIER EN RIETRIVIER

(1) Die onttrekking vir besproeiingsdoeleindes van water uit die genoemde riviere kragtens enige bepaling van die Waterwet, 1956 word gedurende die tydperk 1 April 1984 tot 30 September 1984 ingekort tot 10 persent van die hoeveelheid water wat werklik en wettiglik onttrek is gedurende 1982.

(2) Iemand wat van oordeel is dat hy kragtens subparagraaf (1) daarop geregtig is om water uit die betrokke riviere te onttrek, moet voor 31 Maart 1984 by die Sektie-ingenieur (Vaalrivierseksie), Privaatsak X16, Kroonstad, 9500 (Telefoon 01411-24184), aansoek doen vir 'n magtiging wat hom magtig om water uit die genoemde riviere te onttrek, met vermelding van die gronde waarop hy homself geregtig ag op die onttrekking van water uit die genoemde riviere kragtens hierdie kennisgewing.

(3) Die Sektie-ingenieur of enige ander beamppte van die Departement deur hom vir die doel aangewys, moet elke aansoek oorweeg en homself tevrede stel dat die applikant kragtens subparagraaf (1) geregtig is om 'n bepaalde hoeveelheid water uit die genoemde riviere te onttrek en moet,

SCHEDULE

A. MOOI RIVER AND SCHOONSPRUIT

The measures imposed by General Notice 91 of 3 February 1984 are applicable.

B. VAAL RIVER FROM VAAL DAM DOWNSTREAM TO THE CONFLUENCE WITH THE ORANGE RIVER

(1) Water supplied from or by means of Government water works from the above-mentioned river, shall during the period 1 April 1984 to 30 September 1984 be limited to 800 cubic metres in respect of each hectare of land scheduled in terms of section 63 of the Water Act, 1956.

(2) The abstraction by means of private water works of water for irrigation purposes from the said river in terms of any provision of the Vaal River Development Scheme Act, 1934, or the Water Act, 1956, shall during the same period be curtailed to 10 per cent of the quantity that may in terms of the said Acts be abstracted during an irrigation year.

(3) (a) Any person who in terms of the said Acts is entitled to abstract water from the said river for irrigation purposes by means of privately owned water works, shall before 31 March 1984, make application to the Circle Engineer (Vaal River Circle), Private Bag X16, Kroonstad, 9500 (Telephone 01411-24184), for an authority specifying the reduced quantity of water which he may in terms of this notice during the said period abstract from the said river and subject to paragraph D, the hours of each week during which such abstraction may take place.

(b) No person shall during the period 1 April 1984 to 30 September 1984 by means of privately owned water works abstract any water for irrigation purposes from the said section of the Vaal River, except on the authority of an authority in terms of subparagraph (3) (a) and in accordance with the provisions of such authority.

(c) The Circle Engineer (Vaal River Circle) may at any time after notice in writing to a person to whom an authority has been issued, amend the provisions thereof if he is of the opinion that the required curtailment to 10 per cent will not be attained over the period 1 April 1984 to 30 September 1984.

C. VAAL RIVER UPSTREAM OF VAAL DAM AND ALL ITS TRIBUTARIES UPSTREAM AND DOWNSTREAM OF VAAL DAM EXCEPT THE MOOI RIVER, RHENOSTER RIVER, SCHOONSPRUIT, VET RIVER, HARTS RIVER AND RIET RIVER

(1) The abstraction for irrigation purposes of water from the said rivers on the authority of any provision of the Water Act, 1956, shall during the period, 1 April 1984 to 30 September 1984 be curtailed to 10 per cent of the quantity of water actually and legally abstracted during 1982.

(2) Any person who is of the opinion that he is in terms of subparagraph (1) entitled to abstract water from the rivers concerned, shall before 31 March 1984, make application to the Circle Engineer (Vaal River Circle), Private Bag X16, Kroonstad, 9500 (Telephone 01411-24184), for an authority authorising him to abstract water from the said rivers, setting out the grounds on which he considers himself entitled to the abstraction of water in terms of this notice from the said rivers.

(3) The said Circle Engineer or any other officer of the Department designated by him for this purpose, shall consider each application and satisfy himself that the applicant is in terms of subparagraph (1) entitled to abstract a certain

(5) Met ingang vanaf 1 April 1984 mag niemand water vir besproeiingsdoeleindes uit die genoemde riviere onttrek nie, behalwe op gesag en in ooreenstemming met die voorskrifte van 'n magtiging uitgereik deur die Sektie-ingenieur.

D. BEPERKING VAN DIE URE VAN ELKE WEEK WAARTYDENS OPENBARE WATER INGEVOLGE MAGTIGINGS BEDOEL IN PARAGRAAF B (3) EN C (3) VIR BESPROEIINGS- EN ANDER LANDBOU-DOELEINDES ONTTREK MAG WORD

(1) Elke magtiging kragtens paragraaf B (3) of C (3) uitgereik, moet die tyd tussen 06h00 en 18h00 op Woensdag van elke week vermeld, waartydens openbare water vir besproeiingsdoeleindes kragtens die betrokke magtiging onttrek mag word.

(2) (a) Elke persoon aan wie 'n magtiging kragtens paragraaf B (3) of C (3) uitgereik is, moet uit die hoeveelheid openbare water wat hy daardeur gemagtig word om vir besproeiingsdoeleindes te onttrek, voorsiening maak vir sy gebruik vir alle ander landboudoeleindes.

Kragtens die bevoegdheid aan my verleen by paragraaf 2 (a) van Algemene Kennisgewing 771 van 7 Oktober 1983, wysig ek, Harold Norman Lansdell, in my hoedanigheid van Sektie-ingenieur (Oos-Transvaal), met ingang van die publikasie van hierdie kennisgewing, die genoemde kennisgewing deur die Bylae daartoe deur die volgende Bylae te vervang:

"BYLAE

1. Niemand mag behoudens paragraaf 2 gedurende enige week openbare water vir gebruik vir enige doel uit die Olifants-, Bloed-, Moses- of Elandsrivier neem nie, behalwe tussen 07h00 en 13h00 op elke Maandag, Dinsdag, Woensdag, Donderdag en Vrydag.

2. (a) Geen openbare water mag op Gedeelte 27 van Diepkloof 44 JS uit die Bloedrivier geneem word nie;

(b) Op Gedeelte 20 van Diepkloof 44 JS mag openbare water uit die Bloedrivier geneem word slegs tussen 12h00 en 15h00 op Maandag, Dinsdag, Woensdag, Donderdag en Vrydag van elke week."

quantity of water from the said rivers and shall, subject to subparagraph (4) issue to the applicant an authority authorising him subject to paragraph D, to abstract a specified quantity of water from the said rivers during the hours of each week prescribed in the authority, which will result in the required curtailment to 10 per cent being attained over the period 1 April 1984 to 30 September 1984.

(4) The Circle Engineer or other officer concerned, shall issue an authority subject to the conditions that abstraction only takes place from natural flow in the said rivers (if any), and that releases of water from the Sterkfontein Dam into the Nuwejaarspruit and Wilge River or water pumped upstream from Vaal Dam to Grootdraai Dam in the Vaal River, shall not be reduced by such abstraction.

(5) With effect from 1 April 1984, no person shall abstract water for irrigation purposes from the said rivers except on the authority and in accordance with the provisions of an authority issued by the said Circle Engineer.

D. CURTAILMENT OF THE HOURS OF EACH WEEK DURING WHICH PUBLIC WATER MAY IN TERMS OF AUTHORITIES REFERRED TO IN PARAGRAPHS B (3) AND C (3) BE ABSTRACTED FOR IRRIGATION AND OTHER AGRICULTURAL PURPOSES

(1) Each authority issued in terms of paragraph B (3) and C (3) shall specify the time between 06h00 and 18h00 on Wednesday of each week, during which public water may in terms of the relevant authority be abstracted for irrigation purposes.

(2) (a) Every person to whom an authority in terms of paragraph B (3) or C (3) has been issued, shall, from the quantity of public water which he may in terms thereof abstract for irrigation purposes, provide for his use for all other agricultural purposes.

(b) Any person who is entitled to abstract public water from any of the said rivers for use for any other agricultural purpose except irrigation, may abstract such water only between 06h00 and 18h00 on Wednesday of each week in terms of an authority issued by the said Circle Engineer and during the time specified in the authority.

CURTAILMENT ON THE USE FOR ANY PURPOSE OF PUBLIC WATER FROM THE OLIFANTS, BLOED, MOSES AND ELANDS RIVERS WITHIN THE LOSKOP GOVERNMENT WATER CONTROL AREA

By virtue of the powers vested in me by paragraph 2 (a) of General Notice 771 of 7 October 1983, I, Harold Norman Lansdell, in my capacity as Circle Engineer (Eastern Transvaal), hereby amend the said notice by the substitution for the Schedule thereto of the following Schedule with effect from the date of publication of this notice:

"SCHEDULE

1. No person shall subject to paragraph 2, during any week abstract public water for use for any purpose from the Olifants, Bloed, Moses and Elands Rivers within the Loskop Government Water Control Area except between 07h00 and 13h00 on any Monday, Tuesday, Wednesday, Thursday and Friday.

2. (a) No public water may be abstracted from the Bloed River on Portion 27 of Diepkloof 44 JS;

(b) On Portion 20 of Diepkloof 44 JS, public water may only be abstracted from the Bloed River between 12h00 and 15h00 on Monday, Tuesday, Wednesday, Thursday and Friday of each week."

Placing of languages: *Government Gazettes*

1. Notice is hereby given that the interchange of languages in the *Government Gazette* no longer takes place quarterly, but that it will now be done annually, starting on 1 October until 30 September, every year.
2. For the period 1 October 1983 to 30 September 1984, Afrikaans is to be placed FIRST, changing annually hereafter.
3. This arrangement is to bring the *Government Gazettes* in conformity with Gazettes containing Acts of Parliament etc. where the language sequence remains constant throughout the sitting of Parliament.
