**SOUTH AFRICAN RESERVE BANK**

The following orders are hereby made in terms of Proclamation R. 184 of 1967:

(1) Notwithstanding the provisions of section 17 (1) (a) and (b) of the Banks Act, 1965 (Act 23 of 1965), as amended, every banking institution, except a discount house, that is registered or provisionally registered in terms of the aforementioned Act shall maintain with effect from the date of

in die jongste maandopgawe wat deur sodanige bankinstelling ingevolge artikel 13 (1) (a) van bogemelde Wet aan die Registrateur van Banke voorgelê is.

(2) Elke bankinstelling, behalwe 'n diskontohuis, wat ingevolge die Bankwet, 1965 (Wet 23 van 1965), soos gewysig, geregistreer of voorlopig geregistreer is, moet, met ingang van 14 Maart 1984, by die Suid-Afrikaanse Reservewebank 'n reserwesaldo hou ten bedrae van nie minder nie as 2 (twee) persent van die bedrag van sy middeltermynverpligtigs teenoor die publiek in die Republiek, soos aangegee in kolom (2) teenoor pos 3 in die jongste maandopgawe wat deur sodanige bankinstelling ingevolge artikel 13 (1) (a) van bogemelde Wet aan die Registrateur van Banke voorgelê is.

Die minimum reserwesaldo wat ingevolge hierdie bevel gehou moet word, maak deel uit van die minimum bedrag aan likwiede bates wat ingevolge paragraaf (b) van bevel (1) hierbo deur 'n bankinstelling teenoor sy middeltermynverpligtigs teenoor die publiek in die Republiek gehou moet word.

BYLAE

### (1) Ngaganerivier:

(a) *Gebruik vir besproeiingsdieleindes.*—Algemene Kennisgewing 558 van 22 Julie 1983 soos gewysig deur item (7) van die Bylae tot Goewermentskennisgewing 143 van 27 Januarie 1984, word hierby in geheel herroep.

(b) *Gebruik vir stedelike en nywerheidsdieleindes.*—Algemene Kennisgewing 218 van 18 Maart 1983 soos gewysig deur Algemene Kennisgewing 260 van 11 April 1983 en item (8) (a) van die Bylae tot Goewermentskennisgewing 143 van 27 Januarie 1984, word hierby in geheel herroep.

(c) *Umkomaasrivier.*—Algemene Kennisgewing 773 van 7 Oktober 1983 met betrekking tot die gebruik van openbare water vir besproeiingsdieleindes uit die Umkomaasrivier en al sy sytakke stroom op van die plaas Mimosa Brae 2085, word hierby in geheel herroep.

certification of its monthly return (BA Form 7) for 29 February 1984, liquid assets, as defined in section 1 (1) of the aforementioned Act—

(a) against its short-term liabilities to the public in the Republic, to an amount of not less than 25 (twenty-five) per cent of the amount of such liabilities as shown in column (1) against item 3; and

(b) against its medium-term liabilities to the public in the Republic, to an amount of not less than 18 (eighteen) per cent of the amount of such liabilities as shown in column (2) against item 3,

on the latest monthly return that has been furnished by such banking institution to the Registrar of Banks in terms of section 13 (1) (a) of the aforementioned Act.

(2) Every banking institution, except a discount house, that is registered or provisionally registered in terms of the Banks Act, 1965 (Act 23 of 1965), as amended, shall, with effect from 14 March 1984, maintain with the South African Reserve Bank a reserve balance to an amount of not less than 2 (two) per cent of its medium-term liabilities to the public in the Republic, as shown in column (2) against item 3 on the latest monthly return that has been furnished by such banking institution to the Registrar of Banks in terms of section 13 (1) (a) of the aforementioned Act.

The minimum reserve balance to be maintained in terms of this order shall form part of the minimum amount of liquid assets to be maintained by a banking institution against its medium-term liabilities to the public in the Republic in terms of paragraph (b) of order (1) above.

(3) Government Notice 2149 of 30 September 1983, as published in *Gazette* 8906, is hereby withdrawn.

#### (1) Ngagane River:

(a) *Use for irrigation purposes.*—General Notice 558 of 22 July 1983 as amended by item (7) of the Schedule to Government Notice 143 of 27 January 1984 is hereby withdrawn in full.

(b) *Use for urban and industrial purposes.*—General Notice 218 of 18 March 1983 as amended by General Notice 260 of 11 April 1983 and item (8) (a) of the Schedule to Government Notice 143 of 27 January 1984 is hereby withdrawn in full.

(c) *Umkomaas River.*—General Notice 773 of 7 October 1983 relating to the use of public water from the Umkomaas River and its tributaries up stream of the farm Mimosa Brae 2085 is hereby withdrawn in full.
