WET

Tot wysiging van die Wet op die Onderverdeling van Landbougrond, 1970, ten einde sekere verouderde benamings te vervang; en die verbod op sekere handeling met betrekking tot gedeeltes van landbougrond sonder die skriftelike toestemming van die Minister van Landbou, op te hef; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Staatspresident en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 1 van Wet 70 van 1970, soos gewysig deur artikel 1 van Wet 55 van 1972, artikel 1 van Wet 18 van 1977, artikel 1 van Wet 12 van 1979 en artikel 1 van Wet 18 van 1981.

1. Artikel 1 van die Wet op die Onderverdeling van Landbougrond, 1970, word hierby gewysig—

- (a) deur in paragraaf (a) van die omskrywing van “landbougrond” die woorde “openbare gesondheidsgebied soos omskryf in artikel 1 van die Ordonnansie op die Kommissie vir Plaaslike Gesondheid (Beheer oor Openbare Gesondheidsgebiede)” deur die woorde “ontwikkelingsgebied soos omskryf in artikel 1 van die Ordonnansie op die Raad op Ontwikkeling en Dienste” te vervang; 5
- (b) deur in paragraaf (b) (ii) van die omskrywing van “landbougrond” die woorde “openbare gesondheidsgebied” deur die woord “ontwikkelingsgebied” te vervang; en 15
- (c) deur die omskrywing van “Minister” deur die volgende omskrywing te vervang: 15
“Minister” die Minister van Landbou **[en Visserye]**.”

2. (1) Artikel 3 van die Wet op die Onderverdeling van Landbougrond, 1970, word hierby gewysig—

ACT

To amend the Subdivision of Agricultural Land Act, 1970, so as to substitute certain obsolete designations; and to abolish the prohibition of certain actions regarding portions of agricultural land without the written permission of the Minister of Agriculture; and to provide for matters connected therewith.

(Assented to 9 March 1984.)

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 1 of the Subdivision of Agricultural Land Act, 1970, is hereby amended—
 - 5 (a) by the substitution in paragraph (a) of the definition of “agricultural land” for the words “public health area as defined in section 1 of the Local Health Commission (Public Health Areas Control) Ordinance” of the words “development area as defined in section 1 of the Development and Services Board Ordinance”; Amendment of section 1 of Act 70 of 1970, as amended by section 1 of Act 55 of 1972, section 1 of Act 18 of 1977, section 1 of Act 12 of 1979 and section 1 of Act 18 of 1981.
 - 10 (b) by the substitution in paragraph (b) (ii) of the definition of “agricultural land” for the words “public health area” of the words “development area”; and
 - 15 (c) by the substitution for the definition of “Minister” of the following definition:
 “‘Minister’ means the Minister of Agriculture **[and Fisheries]**”.

2. (1) Section 3 of the Subdivision of Agricultural Land Act, 1970, is hereby amended—
 - 20 (a) by the substitution for paragraph (e) of the following paragraph:
 “(e) (i) no portion of agricultural land, whether surveyed or not, and whether there is any building thereon or not, shall be sold or advertised for sale, except for the purposes of a mine as defined in section 1 of the Mines and Works Act, 1956 (Act No. 27 of 1956); and Amendment of section 3 of Act 70 of 1970, as substituted by section 3 of Act 18 of 1977 and amended by section 2 of Act 12 of 1979.
 - 25 (ii) no right to such portion shall be sold or granted for a period of more than 10 years or for the natural life of any person or to the same person for periods aggregating more than 10 years, or advertised for sale or with a view to

 - (c) by the substitution for the definition of "Minister" of the following definition:—
"Minister" means the Minister of Agriculture [and Fisheries]."
2. (1) Section 3 of the Subdivision of Agricultural Land Act, 1970, is hereby amended—
 - (a) by the substitution for paragraph (c) of the following paragraph:—
(c) (i) no portion of agricultural land, whether surveyed or not, and whether there is any building thereon or not, shall be sold or advertised for sale, except for the purposes of a mine as defined in section 1 of the Mines and Works Act, 1956 (Act No. 27 of 1956), and
 - (ii) no right to such portion shall be sold or granted for a period of more than 10 years or for the natural life of any person or to the same person for periods aggregating more than 10 years, or advertised for sale or with a view to

any such granting, except for the purposes of
a mine as defined in section 1 of the Mines
and Works Act, 1956;” and

5 (b) by the substitution in paragraph (f) for the words “public health area” of the words “development area”.

(2) The provisions of subsection (1) (a) shall be deemed to have come into operation on 4 March 1981.

3. This Act shall be called the Subdivision of Agricultural Land Amendment Act, 1984. Short title.
