PROVINSIALE RAADTUSSENVERKIESINGS.—
KIESAFDELINGS POTGIETERSRUS EN ROSETTENVILLE

Ek, Marais Viljoen, Staatspresident van die Republiek van Suid-Afrika—

- (1) verklaar hierby dat vakatures ontstaan het in die verteenwoordiging van die kiesafdelings Potgietersrus en Rosettenville in die Provinsiale Raad van die provinsie Transvaal, weens die oorlye van mnr. M. C. de G. Genis en mnr. J. P. Hall, lede van gemelde Provinsiale Raad; en
- (2) bepaal hierby ingevolge die bepalings van artikels 34 en 110 van die Kieswet, 1979 (Wet 45 van 1979)—
 - (a) Dinsdag, 22 Mei 1984, as die dag waarop 'n nominasiehof ten opsigte van iedere kiesafdeling gemeld in die eerste kolom van die Bylae hierby, sitting sal hou om nominasies van verkiesingskandidate te ontvang vir vermeldde kiesafdelings;
 - (b) dat bedoelde nominasiehof sitting sal hou op die plek in die derde kolom van genoemde Bylae teenoor die betrokke kiesafdeling aangedui, om 10h00;
 - (c) dat ingeval 'n stemming nodig word in enigen van bedoelde kiesafdelings omdat meer as een persoon behoorlik genomineer is ten opsigte van so 'n kiesafdeling by die sluiting van die betrokke nominasiehof, die stemming op Woensdag, 27 Junie 1984, sal plaasvind, om 07h00 op bedoelde dag sal begin en om 21h00 daardie dag sal eindig; en
- (3) stel hierby ingevolge bedoelde bepalings die persoon wie se naam of amp in die vierde kolom van genoemde Bylae verskyn teenoor die naam van die kiesafdeling, as kiesbeampde aan by die verkiesing in daardie kiesafdeling.

PROVINCIAL COUNCIL BY-ELECTIONS.—ELECTORAL DIVISIONS OF POTGIETERSRUS AND ROSETTENVILLE

I, Marais Viljoen, State President of the Republic of South Africa—

- (1) hereby declare that vacancies have occurred in the representation of the Electoral Divisions of Potgietersrus and Rosettenville in the Provincial Council of the province of the Transvaal on account of the demise of Mr M. C. de G. Genis and Mr J. P. Hall, Members of the said Provincial Council; and
- (2) hereby determine, in terms of the provisions of sections 34 and 110 of the Electoral Act, 1979 (Act 45 of 1979)—
 - (a) that Tuesday, 22 May 1984, shall be the day on which a nomination court will sit in respect of each electoral division mentioned in the first column of the Schedule hereto, to receive nominations of candidates for the said electoral divisions;
 - (b) that the said nomination court shall sit at the place mentioned in the third column of the said Schedule opposite the electoral division concerned, at 10h00;
 - (c) that if a poll becomes necessary in any of the said electoral divisions for the reason that more than one person shall have been duly nominated in respect of such an electoral division at the close of the sitting of the nomination court in question, the poll shall be taken on Wednesday, 27 June 1984, and shall commence at 07h00 and shall close at 21h00 on that day; and
- (3) hereby appoint, in terms of the said provisions, the person whose name or designation appears in the fourth column of the said Schedule opposite the name of the electoral division, as the returning officer at the election in that electoral division.
