## WET

**Tot wysiging van die Drankwet, 1977, ten einde die verbod op die verlening of oordrag van kruideniers-wynlisensies aan sekere persone en op die verkoop of verskaffing van vonkelwyn deur die houers van kruideniers-wynlisensies op te hef; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.**

**DAAR WORD BEPAAL** deur die Staatspresident en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 32 van Wet 87 van 1977, soos gewysig deur artikel 6 van Wet 117 van 1981.

Vervanging van artikel 147 van Wet 87 van 1977.

**1.** Artikel 32 van die Drankwet, 1977, word hierby gewysig deur in subartikel (1) die woorde wat paragraaf (a) voorafgaan deur die volgende woorde te vervang:

“ 'n Lisensie, behalwe 'n groothandelaars-dranklisensie, bierbrouerslisensie, wynboerlisensie, buitelandse dranklisensie, ~~of~~ hoteldranklisensie of kruideniers-wynlisensie, word nie kragtens hierdie Wet verleen of oorgedra nie aan—”.

**2.** Artikel 147 van die Drankwet, 1977, word hierby deur die volgende artikel vervang:

“Voorwaarde betreffende soorte drank wat verkoop of verskaf kan word.”

**147.** Dit is 'n voorwaarde van 'n kruideniers-wynlisensie dat geen ander drank as tafelwyn ~~[(behalwe vonkelwyn soos in artikel 2 van die Wet op Wyn,ander Gegiste Drank en Spiritualieë, 1957 (Wet No. 25 van 1957), omskryf)]~~ wat uitsluitlik die produk is van die alkoholiese gisting van die sap van vars druwe en wat nie meer alkohol bevat nie as veertien persent van sy volume, daarkragtens verkoop of verskaf mag word nie.”.

## LIQUOR AMENDMENT ACT, 1984

Act No. 57, 1984

**ACT**

**To amend the Liquor Act, 1977, so as to abolish the prohibition of the granting or transfer of grocers' wine licences to certain persons and of the sale or supply of sparkling wine by the holders of grocers' wine licences; and to provide for matters connected therewith.**

(Assented to 17 April 1984.)*

**BE IT ENACTED** by the State President and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 32 of the Liquor Act, 1977, is hereby amended by the substitution in subsection (1) for the words preceding para-

graph (a) of the following words:

"No licence, other than a wholesale liquor licence, a brewer's licence, a wine farmer's licence, a foreign liquor licence, **[or]** an hotel liquor licence or a grocer's wine licence, shall be granted or transferred under this Act to—".

10 2. The following section is hereby substituted for section 147 of the Liquor Act, 1977:

"Condition relating to kinds of liquor which 15 may be sold or supplied.

147. It shall be a condition of a grocer's wine licence that no liquor other than table wine **[(except sparkling wine as defined in section 2 of the Wine, Other Fermented Beverages and Spirits Act, 1957 (Act No. 25 of 1957))]** which is the product solely of the alcoholic fermentation of the juice of fresh grapes and containing not more than fourteen per cent of alcohol by volume, shall be sold or supplied thereunder."

3. This Act shall be called the Liquor Amendment Act, 1984. Short title.
