I, George de Villiers Morrison, Deputy Minister of Co-operation, acting on behalf and by direction of the Minister of Co-operation and Development, by virtue of the powers vested in him by section 23 (1) (1) and (2) of the Black Local Authorities Act, 1982 (Act 102 of 1982), hereby determine that the Village Council of Jouberton established by Government Notice 1987 of 9 September 1983 is, in respect of its area and subject to the provisions of the said
