(b) dat bedoelde nominasiehof sitting sal hou op die plek in die tweede kolom van genoemde Bylae teenoor die betrokke kiesafdeling aangedui, om 10h00;

(c) dat ingeval 'n stemming nodig word in enigeen van bedoelde kiesafdelings omdat meer as een persoon behoorlik genomineer is ten opsigte van so 'n kiesafdeling by die sluiting van die betrokke nominasiehof, die stemming op Dinsdag, 28 Augustus 1984, sal plaasvind, om 07h00 op bedoelde dag sal begin en om 21h00 daardie dag sal eindig; en

(2) stel hierby ingevolge bedoelde bepalings die persoon wie se naam en amp in die derde kolom van die Bylae hierby verskyn teenoor die naam van 'n kiesafdeling, as kiesbeampte aan by die verkiesing in daardie kiesafdeling van 'n lid van die Raad van Afgevaardigdes.

**GENERAL ELECTION OF MEMBERS OF THE HOUSE
OF DELEGATES**

I, Marais Viljoen, State President of the Republic of South Africa—

(1) hereby determine, in terms of the provisions of section 34, read with section 33, of the Electoral Act, 1979 (Act 45 of 1979), as modified by section 2 (d) and (e) of the Electoral Act Amendment Act, 1984 (Act 42 of 1984)—

(a) that Monday, 30 July 1984, shall be the day on which a nomination court will sit in respect of each electoral division of the House of Delegates, mentioned in the first column of the Schedule hereto, to receive nominations of candidates for election as a member of the House of Delegates for such electoral division;

(b) that the said nomination court shall sit at the place mentioned in the second column of the said Schedule opposite the electoral division concerned, at 10h00;

(c) that if a poll becomes necessary in any of the said electoral divisions for the reason that more than one person shall have been duly nominated in respect of such an electoral division at the close of the sitting of the nomination court in question, the poll shall be taken on Tuesday, 28 August 1984, and shall commence at 07h00 on the said day and shall close at 21h00 on that day; and

(2) hereby appoint, in terms of the said provisions, the person whose name and designation appears in the third column of the Schedule hereto opposite the name of an electoral division, as returning officer at the election in that electoral division of a member of the House of Delegates.
