PUBLIC SERVICE AMENDMENT ACT, 1984

ACT

To amend the Public Service Act, 1981.

(English text signed by the President. Assented to on 13 July 1984).

BE IT ENACTED by the National Assembly of the Republic of Ciskei, as follows:-

Insertion of section 34A in Act 2 of 1981.

- The following section is hereby inserted in the Public Service Act, 1981 after section 34: "Offence of negligently causing deficiency in stores, money or other property.
 - 34A. (1) Any person, who being responsible for any stores, money or other property belonging to, or in the custody or under the control of, any department, office or institution of the Government, so negligently performs his duties as to cause any deficiency in such stores, money or other property, shall be guilty of an offence and liable on conviction to a fine not exceeding one thousand rand or to imprisonment for a period not exceeding twelve months, or to both such fine and such imprisonment.
 - (2) If, in any prosecution for a contravention of subsection (1), it is proved that the accused was responsible for any stores, money or other property belonging to, or in the custody or under the control of, any department, office or institution of the Government and that, while he was so responsible, there was a deficiency in such stores, money or other property, it shall be presumed, unless a satisfactory explanation to the contrary is given by the accused, that he so negligently performed his duties that the said deficiency was caused."

Short title.

This Act shall be called the Public Service Amendment Act, 1984.

(1) Nawuphina umntu, othi eliliso lazo naziphina izitora, imali okanye enye ipropati emniniyo, okanye eselugcinweni okanye ephantsi kolawulo Iwalo naliphina isebe, iofisi okanye iziko lika Rhulumente, ngokungakhathali enze imisebenzi yakhe ngendlela apha enokwenza nakuphina ukusilela kwezo zitora, imali okanye enye ipropati, uya kuba nobutyala bolwaphulo-mthetho yaye esakube egwetyiwe ahlawule ifayini engedlulanga kwiwaka leerandi okanye ukuvalelwa ithuba elingedlulanga kwiinyanga ezilishumi elinambini, okanye kuzo zombini loo fayini kunye noko kuvalelwa.
 - (2) Ukuba, kuko nakuphina ukuxoxwa kwetyala lokutyeshela icandelwana (1), kuboniswe ukuba ummangalelwa nguye obeliliso kuzo naziphina izitora, imali okanye enye ipropati emniniyo, okanye eselugcinweni okanye ephantsi kolawulo lwalo naliphina isebe, iofisi okanye iziko likaRhulumente nokokuba, lo gama ebeliliso njalo, kwakukho ukusilela kwezo zitora, imali okanye enye ipropati, kuya kuthatyathwa ngokokuba, ngaphandle kokuba inkcazelo eyanelisayo echaseneyo ithi inikwe ngummangalelwa, uye wathi njalo wayenza ngokungakhathali imisebenzi yakhe kwaze ke kwakho oko kusilela kuthethwa ngako".
