WYSIGINGSWET OP MENSLIKE WEEFSEL, 1984

Tot wysiging van die Wet op Menslike Weefsel, 1983, ten einde 'n omskrywing met betrekking tot die kunsmatige bevrugting van persone in te voeg.

DAAR WORD BEPAAL deur die Staatspresident en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

artikel 1 van
Wet 65 van 1983.

1. Artikel 1 van die Wet op Menslike Weefsel, 1983, word hierby gewysig deur na die omskrywing van "invoerder" die volgende omskrywing in te voeg:

"kunsmatige bevrugting van 'n persoon' die invoering op 'n
ander wyse as 'n natuurlike wyse van 'n manlike gameet of gamete in die inwendige voortplantingsorgane van 'n vroulike persoon vir die doel van menslike voortplanting, met inbegrip van—
(a) die samevoeging buite die menslike liggaam van 'n manlike en 'n vroulike gameet of gamete met die oog op die plasing van die produk van 'n samesmelting van sodanige gamete in die baarmoeder van 'n vroulike persoon; of
(b) die plasing van die produk van 'n samesmelting van 'n manlike en 'n vroulike gameet of gamete wat buite die menslike liggaam saamgevoeg is, in die baarmoeder van 'n vroulike persoon,
vir so 'n doel;"

HUMAN TISSUE AMENDMENT ACT, 1984

Act No. 106, 1984

GENERAL EXPLANATORY NOTE:

Words underlined with solid line indicate insertions in existing enactments.

ACT

To amend the Human Tissue Act, 1983, so as to insert a definition in regard to the artificial insemination of persons.

(English text signed by the State President.)
(Assented to 12 July 1984.)

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 1 of the Human Tissue Act, 1983, is hereby amended by the insertion before the definition of “authorized institution” of the following definition: Amendment of section 1 of Act 65 of 1983.

5 “‘artificial insemination of a person’ means the introduction
by other than natural means of a male gamete or gametes into the internal reproductive organs of a female person for the purpose of human reproduction, including—
10 (a) the bringing together outside the human body of a male and a female gamete or gametes with a view to placing the product of a union of such gametes in the womb of a female person; or
15 (b) the placing of the product of a union of a male and a female gamete or gametes which have been brought together outside the human body, in the womb of a female person,
for such purpose;”.

- 20 2. This Act shall be called the Human Tissue Amendment Short title. Act, 1984.
